

HENRY TELLS STORY IN COUNTY JAIL

Tears Dim Eyes of Man Who
Last Thursday Killed George
Dodd at Corvallis.

PRISONER EMPLOYED MAN AT NEWPORT LAST SUMMER

Henry and Wife Were Effecting
Reconciliation When Dodd
Interfered in Plans.

The following is a portion of a dispatch from this city which appeared in this morning's Oregonian relative to the Dodd murder at Corvallis on Thursday evening:

Back of the shooting is the old story of Dodd's relations with the slayer's wife. But in this case the aggrieved husband did not shoot when he first discovered the relations, but the case was not yet when his wife left him and brought suit for divorce. The shooting did not come until the dead man broke up a reconciliation, which had been effected between the husband and wife, according to the story Henry told in the Linn county jail here today.

It was with considerable emotion that Henry, who presents a splendid appearance, told his story. He did not display any special emotion when speaking of the actual shooting, though he said little about it, apparently avoiding a discussion of the details of the culmination of the trouble. But when he referred to his wife and the trouble Dodd is said to have caused in his home and especially when he talked of his children, his voice broke repeatedly, and tears streamed down his cheeks.

"George Dodd came to Newport last spring," said Henry, "and I employed him as powder man in some work I was doing on grading contracts. I don't know where he came from or much about him before he came to Newport. He worked until Decoration day, when he went out hunting with my stepson, my wife's oldest boy, and the boy accidentally shot him in the arm. Dodd was laid up for some time, but I kept him on the payroll and paid all his bills. A woman, who claimed to be his sister, came there with her two children and as they were without money I took care of them too."

After Dodd recovered from his injury he resumed work, but it appears that while Dodd was unable to work friendly relations developed between Dodd and Mrs. Henry. Henry says he didn't hear of this situation for a long time, though it was known to many others.

Henry says he couldn't give the date when he first learned of this situation, but said it was early in September, he thought. When he was talking of the beginning of his trouble he was overcome with emotion several times, so could not remember dates clearly.

Broken-hearted at the condition of affairs, Henry told his wife to take the youngest of their four children, a boy 4 years old, and go to her parents at Edenville. Mrs. Henry is a daughter of Mr. Eddy, for whom the station of Edenville on the Corvallis & Eastern railroad is named. This Mrs. Henry did and her husband says that it was his understanding that she was to stay there. Later he learned that she had gone to Corvallis, where Dodd had secured employment in the Benton county bridge across the Willamette river at that city. After going to Corvallis Mrs. Henry resumed divorce proceedings against her husband.

Henry went to Corvallis once to see his boys and also talked to his wife. At that time there was some talk of a reconciliation.

"I went to Edenville and talked to her people and they talked to my friends in Newport and decided that because of the children and because she had always been a good woman until she met this man Dodd I would take her back. I went to Corvallis Wednesday last this purpose. She agreed to come back and I decided I would allow everything at Newport and take her and the children to some new place, forget our trouble and begin life over again."

Yesterday Henry found out that Dodd had come. Mrs. Henry that night when he met his wife yesterday afternoon she said she wanted to do right but confessed that Dodd had her in his power. Henry then sought out Dodd and shot him.

Little is known of Dodd at Newport. He had every appearance of being a foreigner, probably an Italian, though it is not known that such is the case.

COUNTRY DANCE AT MORNING STAR GRANGE WELL ATTENDED

The country dance given at the Morning Star grange hall, six miles northeast of Albany, was attended by a large crowd of young people last evening, many of whom were from this city. Dancing started shortly after 8 o'clock and continued until 2 o'clock in the morning, with an hour for luncheon.

The country people were very hospitable and the dance was greatly enjoyed by the crowd from this city. Music was furnished by the Willard Davis orchestra.

PROHIBITION LECTURES ARE WELL ATTENDED LAST NIGHT

Free Entertainments at Local
Theatres Were Enjoyed By
Many Albany Men.

Two free entertainments were given last night at Dreamland and Hub theatres by the business men of Albany in the interest of the prohibition of the liquor traffic in Albany, with large crowds of men at both places.

L. E. Hamilton presided at Dreamland and E. M. French at the Hub. The speakers were H. L. Sheldon, of the Anti-Saloon League, of Portland, an orator of ability, convincing in his argument, and C. E. Sox, J. S. Van Winkle, F. P. Nutting and W. A. Eastburn, of this city, who spoke along different lines, showing the evils of the saloon business, one that cannot be and never has been regulated, that the blind pig is a part of the lawless side of the business, violated the same as the law against murder and theft, with more convictions than either for the violation of it; that the absence of the saloon has been a splendid thing for Albany, helping during the past six years to make a better and larger city, and among other things that this election at this time was not instigated by Albany people, but by the Salem Brewing Co., making it a travesty on home rule.

The fact was emphasized that this is an Albany affair and only genuine Albany men should vote, not those temporarily here.

A quartet, consisting of Messrs. Prime, Hammer, Little and Munro, made a hit with some appropriate songs, and several timely moving pictures were presented, full of interest, as well as suggestion.

Monday night at the same places there will be more free entertainments, with new pictures and entirely new programs.

CHICAGO MAN VALUES HIS WIFE AT \$2500

Chicago, Nov. 1.—The value of a wife, expressed in dollars and cents, was discussed in the West Chicago avenue court.

Andrew Fierick, 27 years old, said his wife, Frank Fierick, 31 years old, offered to sell his wife to the younger man for \$80.

"If I ever said it, I said it as a joke," Frank Fierick told Judge Uhlir. "I wouldn't sell my wife for \$2,000."

"That isn't a very high estimate to put on your wife," remarked the court.

"Well, say \$2,500."

According to the testimony the elder Fierick reprimanded his nephew for being too friendly with his wife. This was resented by the young man who tied his uncle hand and foot and left him on the floor of his home. The nephew was fined \$100.

TAFT MEN TURNING TO GOV. WILSON

Realize That the Fight in Oregon
Is Between Roosevelt and
Wilson.

TAFT ORGAN IN PORTLAND COMMENTS ON SITUATION

Wilson Will Carry Oregon Is
Predicted of Men Who Are
Well Posted.

Portland, Or., Oct. 31.—Taft leaders have ceased their efforts in behalf of President Taft, realizing that it is hopeless to expect better than third place for their leader in Oregon. They are now admitting, openly, that the state must go to Woodrow Wilson or Roosevelt, and they are expressing the belief and the hope that it will go to Wilson.

The Oregonian, which has from the first been a consistent supporter of President Taft's candidacy, admitted the utter hopelessness of his cause, in an editorial this morning. This editorial, which is but an echo of the sentiment which has been growing for the past three weeks, states frankly that should all of President Taft's supporters in Oregon vote for him he could not carry the state. It continues that an emergency confronts the supporters of President Taft, in which the Taft men must decide whether to stand by the ship, with certain defeat in the state staring him in the face, or to cast his vote for Wilson in opposition to Roosevelt.

Wilson will carry Multnomah county by a good plurality, in the opinion of those who have studied and canvassed the situation carefully. Reports received from over the state lead to the belief that the New Jersey governor will carry the state. This is the belief of men who have long been closely identified with Oregon politics, and have been, and are now Taft men. Two weeks ago these men would not admit that any doubt existed of the ability of President Taft to carry the state. Now they openly admit he is in third place and state their belief that Wilson is in the lead.

The most significant thing in this closing week of the campaign, is not the rapid crystallization of Wilson sentiment and support, but the outspoken and increasingly numerous commendations of Wilson's candidacy by men who, up to this time, have been active and ardent supporters of Mr. Taft. And it is of added significance that these statements do not come from Multnomah county men alone, but from those who are from widely divergent sections of the state. On every hand you hear it, until it has almost become a chant, that because Roosevelt has stolen the state from Taft, he should not be allowed to get away with the fruit of his largesse.

More and more Taft men are daily advocating that Taft votes be cast for Wilson as a matter of political expediency. They are arguing that it is Oregon's five electoral votes that count, and that five electoral votes from Oregon for Roosevelt would be five votes in the Electoral College at Washington for the final dismemberment of the Republican party. They are arguing that Wilson seeks to defeat the Republican party in disunion and honorable combat, but that Roosevelt seeks to destroy it because it refused to be driven by him at Chicago, and because of this they prefer Wilson to Roosevelt. Should Roosevelt be elected president, they see after four years of his administration in the end of the Republican party as a dominant factor in American government. It would seem certain therefore, that "the menace of the Moose" will put Oregon in the Wilson column on Tuesday next.

CHILD IS DYING OF GRIEF OVER MOTHER

Five-Year-Old Boy Pining for
Woman Who Eloped With
Friend of Husband.

San Francisco, Cal., Oct. 31.—Little Alvin Lima, five years old, whose mother ran away with an "affairist" on September 23, is believed by the sisters of St. Francis convent to be dying of grief over her disappearance.

Taking her two daughters, Helen, aged two, and Stella, eight, Mrs. Rose L. Lima hurriedly packed a suitcase and left her home at 1166 Powell street, North Oakland. She left a note to her husband, J. L. Lima, an employee of the Southern Pacific, that she would not see him again.

Lima then placed Alvin and his seven-year-old brother, Leonard, in the asylum. Because Alvin has never been strong the shock of the loss of his mother is said to be killing him.

Lima says his wife went away with Manuel Azevedo, a man whom he befriended. He had been married nine years when he came home one evening to find his wife gone.

Oregon Agricultural College Ex-
perts Will Officiate at the
Annual Show.

PROFESSORS BOUQUET AND LEWIS SELECTED FOR WORK

Demonstration May Be Made of
Diseases Peculiar to Fruit
and Vegetables.

It has now been definitely decided who will act as judges at the coming Apple Fair, which will be held in Albany on the 13th and 14th of this month. Prof. C. I. Lewis, of Corvallis, will judge the fruits, and Prof. A. G. B. Bouquet, also of Corvallis, will judge the vegetables.

Prof. Lewis is at the head of the horticultural department in the Oregon Agricultural college, and Prof. Bouquet is one of the leading instructors in the same department. It would be impossible to find any two persons in the state better posted along horticultural lines, and the association is remarkably fortunate in securing their services.

While these two gentlemen are here they will each deliver a lecture to the patrons of the fair. Prof. Lewis will have for his subject "Pests in the Whitcomb Valley." Many horticulturists are beginning to think that the most profitable crops we can raise here in the center of the valley is pears and this subject will be thoroughly treated by Prof. Lewis.

Prof. Bouquet will lecture upon "Market Gardening," and this should be heard by all the truck farmers in this vicinity. After graduating at the Oregon Agricultural College, Prof. Bouquet went East and spent several years in the large market gardens in the vicinity of New York and Philadelphia, and, after adding this "post graduate course" to his theoretical knowledge of horticulture, he is eminently fitted to give our gardeners information that will prove of great value to them.

Another feature of very great importance that the association is trying to arrange for is to induce the authorities at the Agricultural College to give a demonstration of the diseases peculiar to our fruit trees and vegetables, showing samples of both the trees and fruit, and at the same time give instruction to our people as to how they should treat these diseases so as to eradicate them.
