Gold Production in 1899.

The preliminary estimate of the production of gold and silver in the United States during the calendar year 1800, made by Mr. Roberts, director of the mint, shows a total gold production of \$70,604,170, an increase over the production of last year of \$6,236,670. The production of silver during the year is estimated at \$74.424. 636, an increase during the year of \$4,-040,211. Oregon is credited with product TIMBER LAND, ACT JUNE 3, 1878.ing only \$1,550,387 in gold, an increase over the production of 1898 of about \$400,000. As all familiar with the facts know, this is a very low estimate for this state.

Suing Stage Company for Damages.

At 1 o'clock on the morning of August 8, 1800, the plaintiff alleges that he was thrown from a stage of the defendant and sustained injuries from which he has not yet recovered, and for weich he feels damaged to the extent of \$3000.
