BONDED FOR \$25,000

Littlefield's Ranch, Mines and Water Rights Involved.

David Littlefield, of Auburn, has bonded his ranch, placer mines and water rights, taking most of Elk creek, to Charles S. Warren and W. L. Vinson, of Sumpter.

The figures are withheld, but \$25,000 is supposed to be the consideration involved.

This is considered the best placer property in eastern Oregon, and the ranch property is one of the best in Baker

The water rights are of great value.

Reported Rich Strike in the Free Coinage.

The expectations of V. A. Schilling and Ed Cannon, owners of the Free Coinage mine, adjoining the Golconda, have at last been realized. A report from the mine, received in this city yesterday, announces the discovery of a vein of free gold quartz similar in every respect to that of the Golconda. This strike was made at the drift being run at a depth of 300 feet from the mouth of the tunnel. This cross cut is about 33 feet wide and six feet of it carries ore that gives an assay of \$146.38 to the ton, the rest of it averaging about \$18 to the ton. Messrs. Schilling and Cannon are very much pleased with the showing their property is making, and it would take a great deal, perhaps, to tempt them to dispose of their mine. They sold a small interest some time ago, and the proceeds of this sale is sufficient to enable them to thoroughly open up the mine and erect a mill. The Free Coinage was taken hold of as a prospect about the middle of last summer.-Portland Telegram.
