#### VOTING PRECINCTS.

### Boundary Lines of the Two in Which Sumpter Lies.

The following is the description of the boundaries of the North Sumpter precinct: Commencing at the south-east corner of section 27, tp 9 s, r 37 E. W. M., thence north on the section line between section 26 and 27 of said township and range to the north-east corner of section 22 of said township and range, thence west on the section line on the north-side of sections 22, 21, 20, 19, in tp 9 s, r 37 e, and sections 24, 23, 22, in tp 9 s, r 36 E. W. M., to the summit of the mountains, which is also the Grant county line to the north-west corner of South Sumpter precinct, thence easterly along the line of South Sumpter precinct to the place of beginning.

South Sumpter precinct consists of that territory bounded by a line commencing in the center of a square formed by the intersection of Mill and Granite streets of the city of Sumpter, thence east along the center of Granite street, across Columbia street and east along the center of Granite street to the section line running north and south between sections 20 and 28, to 9 S, r 37 E. W. M., thence south on said section line to the south-east corner of section 29, said township and range, thence east along section line between SARTISTIC SIGN WORK sections 28 and 33 to 9 r 37 to the west line of McEwen precinct, thence south along said west line of said precinct to the summit of the mountains dividing the waters of Powder river and Burnt river, thence north-westerly along the summit of said range of mountains to the line dividing Grant and Baker counties, thence due east to the section. line running north and south between sections 27 and 26, tp 9 s, r 36 e, thence south on said section line to the south-east corner of section 27. tp o s, r 16 c, thence east along the section line between sections 26 and 35, tp 9 r 36 to the middle of the main channel of Powder river to the center of Granite street, in the city of Sumpter, thence east along the center of Granite street to the place of beginning.

#### Possibilities of the Sumpter District.


