##### Early Argonauts' Names on Cliffs.

Near Hope brothers' old ranch, about two miles from Vale, are some very interesting cliffs of sandstone. They are interesting, first, from the fact that there are no other walls of rock like them within a long distance and, second, from the evidence of early history that is found on

and about them. Evidently the early Oregon immigrant trail has passed near them, for on the rocks are carved names and dates of quite early times. The name of Paul Rosser bears the date of 1852. R. A. Gray, 1864, appears on the face of the rock considerably beyond the reach of a person standing on the ground below. But below this is the name that takes one back to the time when the First Oregon Volunteers were fighting Indians in this part of the country. It is "S. Popoon, Lt. 1st O. V., 1864." It would be interesting to know who this lieutenant was and what has become of him. Perhaps he was killed in some skirmish, and it may be that he is still alive and a citizen of this state. But something of no less interest is that which is found in the ground of the farm above mentioned. On this place, below the cliff and near the river, have been plowed up rusty wagon tires, irons for ox yokes, chains and other things of a similar nature. It would seem that this had been a scene of some early calamity, such as an Indian massacre. Any reader of this who may know anything of further interest concerning this subject will confer a favor on the Gazette by giving us the facts.—Vale Gazette

##### That Gold Medal.

When the Spokane Industrial Exposition was held last October, one of the most attractive departments of the entire show was a grand collection of the mineral products of the entire Northwestern states, and British Columbia, and there was a gold medal offered to the district making the best display of ores. As a natural consequence of having ores that would attract attention in any part of the word, the Sumpter district was easily enabled to carry off the honors and Paul E. Poindexter, who was designated by the Sumpter people to go with the display and otherwise represent the district, returned with that gold medal, bearing the following inscription: "Awarded to Sumpter, Oregon, for the Best District Exhibit of Ores." In collecting this display, Mr. Poindexter spent several weeks in visiting the various camps around Sumpter and also five weeks in Spokane and, as the writer was there in person, knows that good work was done for this section by its representative. Recently the matter of what had become of the medal, seems to have worried some few people, so Mr. Poindexter went before the mayor and city council at the Saturday night meeting and tendered its keeping, when by motion of A. W. Ellis, a resolution was passed that Mr. Poindexter be appointed the custodian of the medal as long as he remains a resident of Sumpter. This ought to settle the matter of where the medal is for all time, as the holder is in business here and with his family intends to remain here.
