World's Supply of Platinum.

For many years between nine-tenths returned from the Birch Creek coal claims, and nineteen-twentieths of the world's twenty miles from here, to which point supply of platinum has come from Russia. The amount produced has ranged from 6,000 lbs to 8,000 lbs annually. Of late there have been signs that the yield was failing off, although the demand has supply of platinum today is consumed by the electric lamp makers. Among the other uses of the metal are the construction of stills for vitriol, dental work, producing the photographic paper which gives us the "platino type," imparting a silver tint to porcelain, pointing stylotion of the claims has made a report like graphic pens and making non-magnet watch springs and certain parts of telegraphic apparatus. Most platinum is alloyed with two other metals, osmium and men at work, perhaps so soon as next iridium. These latter are separated from the platinum only with great difficulty. When they are separated the iridium and osidum (combined as "iridosmine") have been practically useless except for pointing gold pens .- The Manufacturer.

John Day Valley Coal Fields.

On the farm of James Small, down the valley, is a ledge of bituminous coal, on which a shaft has been sunk and from which Mr. Small took out a quantity of fine soft coal and tested its burning qualities to his satisfaction, even in ordinary wood-burning stoves. When a railroad gets through here Mr. Small thinks coal will be prospected for and found in paying quantities in many places in this valley.
