SOME NORTH FORK MINES.

Lawton People Largely Interested In Good Properties.

That the country tributary to North Fork of the John Day river is destined to be one of the greatest and best mineral belts in the whole Northwest is the opinion of every mining man that visits that section. Indeed, it is the ideal of the quartz miner, and the results obtained from work already accomplished show remarkably good returns in values.

Lawton gentlemen who are operating in that section are, Sam Willson, owner of the Nonpareil group, Eugene Abbott, owner of the Myriad group, Messrs. Robinson, Kennison and Johnson of the Homestake and Sheridan, Messrs. Needham and Clanton, owners of the Dalles, Lawton and Ethel L. groups, I. B. Yates, owner of the Rainbow group, comprising the Rainbow, Cliff, Huckleberry and two other claims. Messrs. Padrick, Benson and McElroy also have some promising prospects, but the name of the property has slipped the reporter's mind.

All of these properties show encouraging values which will unquestionably greatly increase with depth, and therein lies the chief merit of the country whose towering hills stand at an angle of 35 degrees, thus enabling the mine worker to attain great depth at a comparatively small outlay of labor and cash.

There is an abundance of timber on all these hills and the John Day river affords ample power if developed, to run the stamp mills of the world.—Lawton Standard.

Lawton Townsite Title Clear.

The protest of J. N. Ditmars and Grant Thornburg, the proceedings of which was heard in La Grande recently, has been dismissed and a decision rendered by the local office that the land occupied by Lawton townsite is non-mineral
