

D'LAMAR BUYS MINES.

Pays \$140,000 for Property Near Susanville.

John Harrington, a big mine dealer, spent several days in Pendleton this week. He left Friday for Susanville, accompanied by his wife, to consummate a deal of 14 mining claims for \$140,000. He has two offers to accept, the one mentioned and one to bond the mines at a much higher price. The second party to the deal is Captain DeLamar, one of the most extensive mining dealers of the west and who has just completed the sale of a \$2,000,000 mining property near Redding, California.

John Harrington at one time was a Denver millionaire, but in the vicissitudes of a mining career, a large part of his fortune disappeared. He is again recovering his lost wealth. At Goose creek in southern Oregon, he has some rich mines where he spends the most of his time.

The fact that Captain DeLamar is to become interested in the Susanville mining camp means no small thing for the future of the place. He will develop the claims extensively and erect machinery for handling the ore, which he doubtless considers valuable. Captain DeLamar owns large mining properties in southern Idaho, and at the cities of DeLamar and Silver City he took hundreds of thousands of dollar from the ground.

John Harrington says that Oregon is the greatest mining state in the Union and that its future will show wonderful development of rich mines. The peculiar thing about Oregon ledges is that they do not pinch out as they go down. The prospects that Susanville will become a good camp are exceedingly bright. A strike has been recently made on an extension of the Badger mine, which has caused some excitement. John Wringle, of Colfax, Wash., who is interested in this claim, passed through Pendleton recently on his way to Susanville, and he claims that the ore is rich and the quantity abundant. The Badger is no longer a prospect, but a magnificent piece of property.

Work on the Yellow Jacket property near Mountain Home continues, and the claims of the Independence mining company are being developed. No assays have been made recently, but some valuable looking rock has been taken out. The company is preparing for some big development work during the summer.—Pendleton Tribune.

John McGuigan's Funeral.

The funeral of John McGuigan, held at the church of St. Aloysius on the north side yesterday morning, was one of the largest held in Spokane for many months. The route to Fairmount was followed by about seventy five carriages, many of the Order of Elks being present. The floral offering was a feature, the casket being buried in them.
