THAT PANHANDLE CASE.

Mandamus Proceedings Instituted Against Union County Officials.

District Atterney Sam White yesterday morning filed papers in the case of Baker county vs. G. W. Benson, clerk of Union county. This case will determine the validity of the act of the legislature annexing a portion of Union county to Baker county, and is a mandamus proceedings against said clerk to compel him to transmit the papers and records in his office pertaining to persons and property within the annexed county.

This is what is known as a special proceeding and will be heard and determined in chambers by Judge Eakin at an early day and the status of the Panhandle determined by judicial decision.

The Union Republican has seen fit to criticise Mr. White's interest in behalf of Baker county, forgetting that it is Mr. White's duty to see that all laws passed by the legislature are enforced. Mr. White represents Baker county for this reason. The officials of Union county have refused to obey the law. It is Mr. White's duty therefore to enforce the law against all violators thereof, whether they be officials or otherwise.

Before proceeding in this matter and to determine his duty in the premises, it may be stated for the benefit of a few Union county people that Mr. White consulted Judge Eakin and his honor advised him that it was perfectly legitimate and proper to take the course he has.—Democrat.
