Humbolt Company Sinking 75 Feet in the Bed of Canyon Creek.

A News representative visited the scene of operations of the Humbolt Mining company this week and saw considerable activity.

The company has a crew of men at work sinking a 75-foot shaft in the bed of Canyon creek, about a half a mile below town, in order to get below the strata of hardpan and determine whether a rich strata of gravel exists beneath. The shaft has aiready been sunk to a depth of
