How to Make Blue Prints Waterproof.

Immerse in melted paraffine until saturated, a number of pieces of an absorbent cloth a foot or more square and when withdrawn and cooled they are ready for use at any time. To apply to a blue print, spread one of the saturated cloths on a smooth surface, place the dry print on it with a second waxed cloth on top, and iron with a moderately hot flat iron. The paper immediately absorbs paraffine until saturated and becomes translucent and highly waterproof. The lines of the print are intensified by the process, and there is no shrinking or distortion.-Mines and Mining.
