It now develops that one of the motives actuating the people with a pull who engineered the forest reserve land grabbing deal, was to exchange worthless land from which the timber has all been cut for lieu land scrip, to be placed on valuable timber lands. It is the clearest case of getting something for nothing yet placed on the public records. It is a steal and the politicians on whom the responsibility of the job can be placed, may as well consider it as their political death sentence in this state. The Oregon Lumber company and the Sumpter Valley Railway company, practically the same thing, are the chief beneficiaries. This outfit has several t housand acres of logged land in Baker county which it will thus be enabled to trade for timber lands.

Again the American makes an elaborate defense of Cato Johns in the matter of the illegal method pursued in expending school funds-or rather, attempting to run the district in debt. Its plea is that old cowardly chestnut, "it may be all wrong, but don't say a word, for fear of injuring our credit and schools."
