#### LATEST STRIKE IN THE GOLCONDA

## Six Eeet of \$150 Ore Encountered in the 100-Foot Level.

J. A Howard came in from the Golconda this forenoon and confirms the report which he telephoned in yesterday regarding the latest strike in that prop-

It was encountered while drifting on the 100-foot level, at a point about in line with the dip of the ore shoot carrying the marvelously high values that have made this mine famous throughout the world, a veritable realization of what its name implies.

When first found Monday night there was only a few inches of the ore, that assayed \$764. After twenty-four hours work it has widened out to full six feet, with gold values clear across the face of \$150. Mr. Howard says that there is every indication that there is a large body of valuable strike ever made in the mine; notwithstanding the fact that on the next lower level rock carrying \$50,000 has been mined.

The ore now being taken out will be sacked.
