We have the usual number of peace officers here, but their living does not come from administering justice to evil doers. In fact one of our justices of the peace when he found his income from the office was so small, thought of turning his attention to gambling so as to make a living but reconsidered the matter and compromised on the real estate business. People from a distance who contemplate settling in or visiting our mining camps will find their person or property is as safe as any where in the world.
