SNOW CREEK TO THE FRONT.

MINE MAKES GOOD SHOWING IN HIGH GRADE ORE.

Manager Smith Returns From Property and Reports Things Looking Good-Fine Spokane. Quality of Ore Being Extracted-Plans for Mill Soon to be Completed.

F. D. Smith, of the engineering and mining firm of Browne & Smith, general manager of the Snow Creek mine in the Greenhorn district, returned this week from a trip to the property and reports everything moving along very encouragingly. A steady force is at work and 164 feet of crosscut was completed last month. The company is now blocking out ore, getting ready for the ten-stamp mill which is to be built this summer. This plant is to have a daily capacity of twenty-five tons and Mr. Browne is now at work on plans for its construction. He has also just completed a map of the new workings of the mine.

The property is making an extraordinarily fine showing. From five sets drifted on the ledge averages of \$30.65 were obtained, making the sixty-seven tons of ore thus extracted and placed on the dump worth \$2,053.55. The total cost of mining this amount of ore according to Mr. Smith's time book and expense sheet was \$98.65.

When the fact is taken into consideration that the milling of this high grade ore costs only about \$1 a ton, the profit is clearly seen. Besides this the company between 1,500 and 1,600 tons of ore now on the dump. All the ore is free milling of a fine quality.

By actual experiment, Mr. Smith fluds that it is cheaper to do the development work himself than to let it to contract. Up to March 1 the work by contract cost \$6 a foot. Since that time Mr. Smith has been employing men and having it done under his own supervision with a cost in the present crosscut of only \$3.36 a foot, including everything asisted by the choir. except the fixed expenditures. The company will soon have the plans of its new mill completed and will ready to start mining operations on a more extensive scale.
