BEST CAMP IN THE COUNTRY.

THIS IS THE OPINION OF MINING EXPERT KOPLIN.

After Experting Little Cracker Group Wires His People That Property is Better Than Represented-Fine Mine-Power Drills to be Put in-Development to go Forward.

L. E. Koplin, of Duluth, who came here a few days ago to expert the Little Cracker property for some of the eastern stockholders and others interested, before leaving yesterday, sent the following wire to his employers:

Speaking of the situation Mr. Koplin said:
