Company Organized to Develop Pulaski Group.

Nine Full Claims Admirably Located, Accessable to Travel-Reached by Wagon Road-Well Timbered and Well Watered-Enormous Ledge-High Values-Development to Start at Once.

Articles were drawn up yesterday and forwarded to Salem today fort the incorporation of the Pulaski Mining and Milling company, of Sumpter. The incorporators are W. E. Sanders, J. Rosenthal, R. L. Neill and J. H. MacCallum, and the capital stock is \$150,000, divided into 1,500,000 shares, having a par value of ten cents. The company was organized for the purpose of developing the Pulaski group of claims, situated just back of the city on Cracker Creek, on the divide between the well known Cracker and Deer Creek districts, and 500,000 shares are placed in the treasury for development. A force of men is to be started to work at once.

The Pulaski group embraces nine full claims located less than a mile from the city in a northerly direction. They are, the Pulaski, the Gray, the Odessa, the Avalanch, the Marie, the Porphyry, the May, the Montgomery and the Addenda. The group was originally located by the Griffin Brothers in the winter and High Grade Stringer or Shoot spring of 1898. Some prospect work was done by them and exceptionally high surface values encountered. Great interest was excited in the property at the time and the locators refused an offer of \$10,000 in cash and a bond of \$50,000. They held on until last year when they sold out


