# Interesting Story Told by Judge Evans.

Judge Evans, of this city, learned through a tramp telegraph operator in Colorado in 1898 the details of a tragic search after the yellow metal in Lower California by some deserters from the United States army at National City, California, during the Ensenada excitement in 1886, or about that time. He tells the story as follows:

"The story was told me by one of those versatile hoboes, known as a tramp telegraph operator, and afterwards verified by a visit to Mexico. During the Ensadena excitement four troupers described the army at National City, and started south in quest of gold. What they suffered from thirst and from the burning sands of the Lower California deserts, no one will over know. They wandered about for weeks and months perhaps, finally crossing the Sierra Nevada mountains, and the desert stretch of ninety miles to the shores of the gulf. There three men were discovered aimlessly pacing back and forth on the beach by a passing boat and taken to Angel Island. They were raving maniacs, famished and frenzied for the want of drink and food. From Angel Island in the gulf they were transfered to a mission at Guaymas, in the state of Sonora. On the men was fuond \$14,000 in gold nuggets. They were nursed and cared for at the mission, but two of them died wihout ever regaining their senses. The third became lucid just before death and gave the story of their suffering and of the marvelous wealth they had discovered in the mountains.

"He said that after leaving National City they journeyed southward many days. Their supply of water gave out and the burning heat of the desert became almost unendurable. Their horses were the first to succumb, then one of his companions died. Famished for want of food and parched by thirst, the remaining three finally succeeded in making their way to the mountains. There they encountered a box canyon or coulee as we would call it in this country, where they found water and some game for food. After regaining their strength they decided to explore the canyon, and it was here they fond the wonderful deposit of gold. They secured \$14,000 in nuggets which they picked out of the canyon, and started for the gulf coast, a distance of niney miles across the tropic desert.

"The last survivor was from Buffalo, New York, and his portion of the wealth was sent to his mother. The rest was expended in a monument which marks the final resting place of the three ..

"I visited the mission myself and the priest in charge confirmed every detail of the story as told by the tramp operator. I was looking after that rich placer ground, but the priest informed me that numerous parties had gone in search of it, following the directions given by the dying trouper, but none had succeeded in locating it."
