MINE MANAGEMENT.

Competent Especially Essential.

Speaking of the neglect of details in mine management the Salt Lake Mining Review says:

"In former issues comment has been made on the subject of 'mine management' and of the results following the employment of competent or incompetent superintendents. We have said that no mine, however good, could stand mismangement for any length of time and continue to make profit for owners or shareholders. In the development of a prospect good management is especially essentail, as it is more difficult to obtain money for the development and operation of a prospective producer than it is for the handling of a property of known merit and value. In the development of a prospect, a good manager will pay particular attention to the little details of operation—and they are many. It is an old saying that Wilful Waste Makes Woeful Want. This applies to mining as well as to other occupations, and the careful hereby referred to and made a part superintendent and shift boss will pay as much attention to the economical use of powder, fuse, candles and other mine supplies as he will to the way the men put in their time; and this latter item, by the way, is a feature of mining operation that is often abused to such an extent that, as one mining man recently remarked, 'a miner who soldiers in the mine should be arrested for petty larceny, as a theft of time is a theft of money.' The miner who wastes an hour of his employer's time every shift, and sometimes he is compelled to do so through force of circumstances, may think that it amounts to but little; but, in eight days this amounts to a shift, for which he is paid at the rate of from \$2.50 to \$3.25 a day, and for which no recompence to the mine owner is made in any manner whatever. With a force of a dozen or twenty-five men at work in a mine, waste of time and loss of money means much in the course of three or six months; and, because of this loss, more than one mine in this intermountain country has been forced to close down for the reason that the funds available at the start of operations have been found insufficient to accomplsh results anitcipated; and yet the work may have been intelligently and ably directed and performed in a workmanlike manner.

'We have known a force of men who have been compelled to suspend operations for an hour or more because a short length of ladder had not been supplied when it should similar manner as a general munisystem m providing supplies has often kept many men in a mine in enforced idleness for half a shift. In the operation of machinery the failure to keep duplicate parts on hand, whose use may be hourly expected, is another source of loss of both time and money, and minor detail is so often overlooked that frequently the whole force of a mine is unable to perform good and satisfactory work for a day or two.

"This lack of attention to detail has a most important bearing on the souccessful operation of a mining proposition, and cases are numerous

ORDINANCE NO. 196.

An ordinance providing for the con-City of Sumpter, directing the manner of estimating the cost of issuance of bonds to defray the cost of the same.

The City of Sumpter Does Ordain as Follows:

Sec. 1. That there shall be constructed in the City of Sumpter, a sewer system in accordane it the map thereof and drawings thereof entitled "Map of sewer system of the City of Sumpter", the specifications thereof entitled: "specifications of sewer system", prepared by C. H. Fenner, City Engineer, and designed by Philbrick & Fenner, Civil Engineers, and the estimate of cost thereof made by said C. H. Fenner, City Engineer, all of which are now on file with the City Recorder of the City of Sumpter, Oregon, and are of this ordinance.

Sec. 2. That the cost of said sewer system shall be estimated as shown by the specifications and estimate aforesaid, prepared by said C. H. Fenner, City Engineer, the total cost thereof as shown thereby, to be the sum of \$15,000. That said sewer system shall be constructed at the extherefor to be raised by bonding the City.

Sec. 3. The bonds shall be issued by the City of Sumpter to the amount of Fifteen Thousand Dollars in accordance with the provisions of the City Charter of Sumpter, Oregon, payable in 15 years to draw interest at the rate of 6 per cent per annum, the moneys derived from the sale of said bonds to be used solely in defraying the cost of said sewer system

Sec. 4. That before said bonds are issued, or any indebtedness for said sewer system incurred, an election shall be held as provided by the City Charter; and the making of said improvement and the issuing of bonds therefor, shall be submitted to a vote of the taxpayers of the City at a special election to be held for that purpose.

The City Recorder shall immediately after the passage and approval of this ordinance give notice as provided in the City Charter for the holding of such special election, said notice shall state the time and manner of holding such election and the persons entitled to vote thereat, and said election shall be held in a cipal election Sumpter.

ORDINANCE NO. 197.

That said improvement shall consist of establishing a grade of said street, removing all obstructions therefrom, grading the same to the grade so established and laying all necessary gutters along said street.

Said improvement to be made at the expense of the property owners to be benefited thereby as provided by the City charter.
