BRIDGES BROKE.

**Boiler for Midway Smashes
Two on Bourne Road.**

The bridge near the Halfway House on the Bourne road was smashed yesterday by the Scotch marine boiler being transferred to the Midway. This makes the second bridge broken through. The engine is 125-horse power, furnished by the Holthoff Machinery company, and together with the trucks on which it is being hauled weighs 24,000 pounds. The hoisting machinery recently delivered has been set at the Midway and will be operated as soon as the boiler arrives. This is a matter dependent upon the strength of the bridges intervening.

BLIND LEDGE.

Shots Revealed Unknown Vein at McKinley & Roosevelt.

Shots broke through the footwall of a blind ledge yesterday. This was unsuspected. Its width is yet unknown. It is estimated that the main ledge is about 100 feet distant from the present workings.

STRINGERS CUT.

**Driving Crosscut For Main Pulaski Vein
About 200 Feet Distant.**

Foreman Raven, of the Pulaski, reports that several rich stringers have been cut during recent development.

The workings have been substantially timbered and the crosscut is being driven for the main ledge of the property as rapidly as possible. It is estimated that the vein will be encountered in considerably less than 200 feet.
