The \$30,000,000 Sweeney merger has been accompished and Charles Sweeney of the new Federal Mining and Smelting company, has the honor of perfecting the deal. The final act of turning over the big Coeur d'Alene mines to the new corporation was made a few days ago in New York, when entire payment was made for the Standard, Empire State-Idaho and Mammoth.

Several companies operating in the Sumpter district have adopted the plan of issuing frequent reports to stockholders regarding the progress of development work and items of general interest to the average man who has invested his money. the correct system and one that saves a lot of worry and correspondence that is easily avoided in this way. Speaking along this line Bonds and Mortgages says: "The company that issues frequent reports to its stockholders has the confidence of investors and meets with the greatest success in the placing of its stock. When a person buys a thousand or ten thousand shares of stock in a mining company he acquires a lively interest in the physical and financial condition of the company. He wants to hear about it occasionally. He wants to hear what is being done at the property, even though the report be unfavorable. Some promoters give monthly reports until the company is financed and then forget there are stockholders waiting for dividends. The reports are stopped and the stockholders are left in the dark as to operations and finances. No man or set of men who have any regard for their business future can afford to treat their clients in this manner. The client is in reality entitled to more consideration at the hands of the promoter after he has invested his money than before. When this fact is better understood by promoters there will be more money for the development of the many excellent mining propositions throughout the west. There is another advantage in the policy of frequent reports. With this system being practiced the promoter is constantly on the alert to make a good showing. It would be a wise move to compel, by legislation, all mining companies to render a careful report to their stockholders at least once

Mr. Ovitt has had his experience with cut rate brokers, regarding which he says:

"These people are doing legitimate mining a great deal of harm, but they are gradually going out of business as the searchlight of publicity is being turned on them. Several suits are now pending where the cut raters have advertised stock they could not deliver. In my own experience, when I sought to buy stock of any of our properties advertised at a cut rate figure, the broker was usually 'just out.

Mr. Ovitt is among the heaviest advertisers operating in this district. He states that from an expenditure of \$80,000 in advertising, he realized a return of \$652,000.
