

ORDINANCE NO. 202.

An ordinance declaring the probable cost of improving Granite Street from the east line of Mill Street easterly to the west line of Columbia Street, and assessing the proportionate share thereof chargeable to each lot or parcel thereof, liable for said improvement.

The City of Sumpter does ordain as follows:

Sec. 1. The Common Council of the City of Sumpter having ascertained the probable cost of improving Granite Street in said City from the east line of Mill Street easterly to the west line of Columbia Street in said City, does hereby declare the probable cost of said improvement to be the sum of \$796.79; and said sum is hereby assessed to the several lots or parcels thereof liable for the cost of said improvement in the respective amounts set opposite the number and description of each particular lot or parcel in section 3 of this ordinance:

Sec. 2. The recorder of the City of Sumpter is hereby directed to enter a statement of the assessment hereby made in the docket of City Liens, and as soon as said entry is made, to give ten days notice thereof as required by Section 102 of the City Charter:

Sec. 3. The amount assessed against each lot or parcel thereof for the cost of said improvement, and the name of the owner of said lot or parcel, is as follows:

ORDINANCE NO. 203

An ordinance declaring the probable cost of improving Columbia Street from its intersection with the South line of East Granite Street extending westerly across Columbia street to the east line of block 11, Sumpter Heights, McEwen's addition to Sumpter, to the south line of North street in said city, and assessing the proportionate share thereof chargeable to each lot or parcel liable for said improvement.

The City of Sumpter does ordain as follows:

Sec. 1. The Common Council of

the City of Sumpter having ascertained the probable cost of improving Columbia Street from its intersection with the South line of East Granite Street extending westerly across Columbia Street to the East line of block 11, Sumpter Heights, McEwen's Addition to Sumter, to the South line of North Street in said City, does hereby declare the probable cost of said improvement to be the sum of \$794.90 1/2; and said sum is hereby assessed to the several lots or parcels thereof liable for the cost of said improvement in the respective amounts set opposite to the number and description of each particular lot or parcel in section 3 of this ordinance:
