

ORDINANCE NO. 205.

An ordinance declaring the probable cost of improving Auburn street in the City of Sumpter, Baker County, Oregon, from the east line of Center street to the west line of the alley in the center of block 11, Sumpter Heights, McEwen's addition to the town of Sumpter, extended across said Auburn street, and assessing the proportionate share thereof chargeable to the lots or parcels liable for such improvement.

The City of Sumpter does ordain as follows:

Sec. 1. The common council of the City of Sumpter having ascertained the probable cost of improving Auburn street from the east line of Center street in said City easterly to its intersection with the west line of the alley in block 11, Sumpter Heights, McEwen's addition to the town of Sumpter as shown on the plat of said addition of record in the office of the Recorder of Conveyances of Baker County, Oregon, extended across said street, to be the sum of \$476.18 and that said sum is hereby assessed to the several lots or parcels thereof liable for the cost of said improvement in their respective amounts as set opposite the description of each particular lot or parcel in Section Three of this ordinance.

Section 2. The Recorder of the City of Sumpter is hereby directed to enter a statement of the assessment hereby made in the docket of City Liens, and as soon as said entry is made to give ten days notice thereof as required by Section 102 of the City Charter.

ORDINANCE NO. 206.

An ordinance declaring the probable cost of improving Auburn street from the intersection of the west line of the alley in Block 11, Sumpter Heights McEwen's Addition to the town of Sumpter, extended across said street, easterly to the west line of Ibox street, and assessing the proportionate share thereof to each lot or parcel thereof liable for such improvement.

The City of Sumpter does ordain as follows:

Section 1. The common council of the City of Sumpter having ascertained the probable cost of improving Auburn street from the intersection of the West line of the alley in Block 11, Sumpter Heights McEwen's Addition to the town, now City of Sumpter, as shown on the plat of the said addition now of record in the office of the Recorder of Conveyances of Baker County, Oregon, extended across said Auburn street, easterly to the west line of Ibox street, does hereby declare the probable cost of said improvement to be the sum of \$1035.69, and said sum is hereby assessed to the various lots or parcels thereof liable for the cost of said improvement in the respective amounts as set opposite the description of each particular lot or parcel in Section Three of this ordinance.
