

How to Make Oatmeal Bread

FOOD WILL WIN THE WAR

Political Corner

W. I. Needham, Republican, has filed his petition for the nomination of sheriff at the primaries in May, saying "if nominated and elected will continue to conduct the office to the best of my ability."

"Will endeavor to conduct the duties of my office to the best interests of the tax payers without fear or partiality," is the platform on which J. P. Feller is making his campaign for county commissioner, while W. H. Goulet has adopted the statement: "Will serve the people to the best of my ability, as I have in the past." Ben Robertson, of Turner, who is expected to become a candidate has not yet filed notice of his candidacy.

Last week Judge Bushey and County Fruit Inspector S. H. Van Trump mailed out 375 circular letters to farmers living outside Marion county but who own lands within the county, inviting them to invest in the Third Liberty Loan bonds—a patriotic thing to do. Yet not long since (and probably he feels that way yet) Judge Bushey denied the urgent request of the Federal government for co-operation in maintaining a county agent as a war-time measure. Strange, indeed, how a political campaign develops the patriotism of the Mossback!

Stanfield, one of the Republican candidates for U. S. Senators, voices his approval of the basic 8 hour day for the lumbering industry, with increased pay for the men, and improved working conditions. All on the ground that it will result in maximum efficiency to insure maximum production.

One statement in Governor Withycombe's announcement will puzzle many. "The efficiency of the state service must never be sacrificed for the sake of political advantage." It may be supposed that this shall apply only to a successful opponent, as most of the governors' attempts at "political advantage" have proved abortive. In several instances there has been neither efficiency nor political advantage, for the governor has early and often fallen into the hands of the Philistines.

Judge Percy R. Kelley has been hearing motions and demurrers in Department No. 1 of the circuit court, preliminary to the regular March term, which convened on Monday March 18. Judge Kelley's friends in the legal profession have petitioned him to become a candidate in the May primaries for nomination for the supreme judge and he has consented. In the seven years he has been on the circuit bench, he has given universal satisfaction. Marion and Linn counties will part with Judge Kelley with regret, his nomination being practically assured for there seems to be no opposition. What is the

district's loss, however, is the state's gain, for he will bring to the office experience at the bar and on the bench; a trained mind and a capacity to work.

15 cords second growth fir.

15 cords old fir.

5 cords oak.

The wood must be good, sound, dry wood, well and closely piled in four foot length, ricked up in good shape to be measured just outside the basement window. Delivery to be completed by the first day of September 1918. Bids will be received for each kind of wood separately, or for all as the bidder desires.
