A. W. Krasberger, the 19 year old son of Franz Krasberger of Macksburg met with a painful accident last week Wednesday while working on one of the machines at the Hawley Pulp and Paper Mill at Oregon City. His leg was caught and broken above the ankle. He was taken to the Oregon City hospital for medical attention. His father has been down to Oregon City to see him several times the past week. The young man had been employed at the mill for some time, but had just returned from a lay-off when the accident happened.

LOYALTY LEAGUE MEMBERS
DENOUNCE ENEMY TONGUE

Seventy-five delegates representing 11,000 members of the American Loyalty League in Clackamas county met Saturday at Oregon City. Judge Anderson addressed the delegates, concerning food regulations. A resolution was adopted voicing the sentiments of the League against feeding milable wheat to stock. Rev. John Linder addressed the meeting upon the subject of the Salvation Army war fund drive next month, and the convention adopted resolutions instructing officers of the county league to take immediate steps to eliminate the use of the German language in schools, churches and public places in the county. With their huge membership back of them, a strenuous effort will be made to carry out the instructions of the convention. There are two churches in Oregon City, one at Macksburg, and other places in Clackamas county that continue the use of the enemy language in their services.

BILLY SUNDAY-ISM

Billy Sunday ripped the hide both ways off the Kaiser, exhausting the language in his attempts to describe the Hohenzollern and his fellow criminals the pro-Germans, in his speech at Salem Sunday in behalf of the Salvation Army.

"Gull-necked, weasel-eyed, pretzel-eating, green-eyed ambassador from hell," is his description of the Kaiser.

WATCH FOR THE DAY

If you are one of the 13,000,000 men who must register under the new draft law, you should watch the newspapers for the announcement of the Registration Day. The date cannot be set until the President actually signs the bill, making it law, but there is no doubt that it will be the first or second week in September. Every man from 18 to 30 and from 31 to 45 years of age inclusive must register on the day set. Failure to do so will be punished by a year in jail. For his own protection every man should watch for the announcement of the day set.

The registration place for the Aurora precinct will be at the L. O. O. F. Hall, and Louis Webster will be in charge as chief registrar.
