W. AL. JONES' WILL FILED

The last will and testament of W. Al. Jones, who died Saturday morning Nov. 2, was signed and witnessed at 7 o'clock Friday morning, Nov. 1, 1918. The witnesses to the signing of the will were Goldie E. McFarland and Ronald C. Glover. It was filed for probate recently in the county court.

The estate is valued at \$23,000, and Mrs. Jessie Creighton Jones is named as administrator of the estate, to serve without giving bond.

The heirs are declared to be Mrs. Jessie Creighton Jones, and the two children, May Rosalie Jones, age nine and Creighton Denton Jones, age seven.

In the will the two children are given share and share alike all of the interest of W. Al Jones in the farm home, a part of the Silas Jones donation land claim in Marion county, about eight miles north of Salem. They are also given share and share alike all his war savings stamps.

To Jessie Creighton Jones is given the residue of the estate, both real and personal and in the will she is appointed executrix, to serve without bond—Salem Journal.

CHARLES S. WOLFER DEAD

Charles S. Wolfer, of Milwaukie, died at his home at that place Friday evening November 15, and burial took place at the Aurora cemetery Sunday afternoon. Heart failure following an attack of influenza was the cause of his death. He was ill but a short time having come from the St. John's shipyards, ill the Saturday before his death.

Charles Samuel Wolfer was the son of the late Samuel and Margaret Wolfer, prominent early pioneers of this section, who crossed the plains in 1865, and were among the early Aurora colonists. Mr. Wolfer was born at Needy, Clackamas county, January, the 2, 1884, and has resided in the county during his entire life. On December 13, 1911, he married Miss Mabel Meeks, of Canby, daughter of prominent residents of that place, who survives him, also his three-year-old son, Samuel Raymond Wolfer. Henry A. Holfer of Canby is a brother of the deceased, and Mrs. Grant B. Dimick and Mrs. J. Coleman Mark of Clarks Prairie are sisters.

GIRL'S TESTIMONY GETS CLARENCE PHILLIPS FIRED

A news dispatch in the Portland papers narrates the story of the ousting of Clarence A. Phillips, superintendent of schools of Beaverton, Oregon. Phillips formerly taught here and was twice an unsuccessful candidate for county superintendent of Marion county. At the hearing the girl in the case told the story of meeting Phillips in Portland last summer, and was led to believe that he was divorced. She said he led her to believe he wanted to marry, and easily won her affections. Later she learned he was a married man with a wife and son. The girl's sister and mother, with friends, gave further testimony, which was heard by a crowd which gathered in the auditorium. Phillips called no witnesses, and came near starting several riots during the proceeding by his persistent attempt to break in during the examinations of witnesses.

The school board fired him from the superintendency, and the state superintendent has been asked to revoke Phillips' certificate. He will be given a hearing to show cause why his certificate should not be revoked.

Phillip's trial will come up before state superintendent Churchill at 2 p. m. next Saturday, November 23. The charge against him is immorality and is made by county superintendent Frost of Washington county.

COUNCIL BILL NO. 109

Entitled an ordinance laying a tax on real and personal property in the city of Aurora, Oregon.

The People of the City of Aurora do ordain as follows:

That a tax amounting to the sum of Eight hundred fifty dollars (\$850.00) be and is hereby levied on the real and personal property within the corporate limits of the City of Aurora, Marion County, Oregon, as shown by the assessment roll of Marion County, Oregon for the year 1918, said tax to be used for general municipal purposes.
