LOOKING AT WASHINGTON

**DENOUNCES FARM LOANS
HOOVER TO VETO BONUS
HOUSE RESTORES ORDER
GARNER'S GREAT TRIUMPH
HOOVER'S APPEAL
BANKS AND RAILROADS**

Secretary of Agriculture Hyde is outspoken in denouncing the government's policy of making loans to farmers. He fears that this will stimulate production and continue to keep down the price of farm products, particularly wheat and cotton.

He insists that the loans cannot be called "good business" by the furthest stretch and that the Department "is the prize boob in the history of finance" because it is "lending more money on thinner security and sustaining more losses than ever before in the history of money-lending in the world."

The Secretary says that in 1931 the Department loaned \$50,000,000 and has collected thus far only \$27,000,000. Additional collections are coming in at the rate of \$90,000 a week. He also points out that some loans made in 1921 are still in process of being collected.

The Secretary's ire is apparently directed at a bill pending in Congress to make available the balance of the \$200,000,000 set aside for agriculture when the Government decided to establish a credit fund of \$2,000,000,000 for the Reconstruction Finance Corporation.

Sixteen bills have been introduced in the House to provide additional payment to World War veterans upon their adjusted compensation certificates. The disposition of the bonus is the next business to be taken up by the House after disposing of the tax question.

However, proponents of immediate payment were given emphatic notice by the President that he would veto any legislation providing for additional payment at this time. He was more outspoken than in the anti-bonus appeal delivered at the American Legion Convention at Detroit, following which the organization curtailed its bonus request. The President declared that he was "absolutely opposed to any such legislation."

He insisted that agitation on the case become law.

The President's declaration was made after Republican leaders in the House informed him that a majority sentiment in that body appeared to favor new bonus legislation. He insisted that agitation on the question had created apprehension in the country and that while every effort was being made to reduce government expenditures and balance the budget, that this would be impossible if it was necessary to provide \$2,000,000,000 to pay the balance due on the compensation certificates.

In the Senate, opinion is divided but Senator Reed, of Pennsylvania, believes that enough votes will be available to uphold a presidential veto.

The House of Representatives, after running wild in its opposition to the Sales Tax, was back under the control of leaders following Speaker Garner's personal appeal, which changed the course of the House completely. It was a decided tribute to the Speaker, paid by Democrats and Republicans alike, who arose in a body to express their belief that the budget should be balanced.

Speaker Garner's intervention dispelled the legislative crisis so effectively as to arouse nationwide comment. Undoubtedly, he restored himself as the leader of his party and gained the prestige necessary to off-

G. RUSSELL MORGAN CANDIDATE FOR DISTRICT ATTORNEY

I am 35 years of age, and was born in this county, about a mile south of Hillsboro. I attended the grade and high schools of Hillsboro and was active in all student affairs, being president of Hillsboro High School student body and manager of all athletics for two consecutive years. For two and a half years I attended Pacific University at Forest Grove, and then began the practice of law and attended the Northwest School of Law in Portland, the University of Washington and the University of Oregon. My campaign for the office of District Attorney is based on economy in conducting the office. If nominated and elected I can and will save the taxpayers several thousands of dollars.

Much money can be saved in handling misdemeanors through the various justice courts of the county rather than the expensive procedure of Grand Jury investigations, indictment and trial.

My declaration filed with the secretary of State contains the following statement: "If I am nominated and elected I will, during my term of office conduct the office without a salaried deputy, maintain my office at the Court House, foreclose delinquent taxes in accordance with the law, prosecute vigorously, but not persecute and in general conduct all civil and criminal business of the county honestly, efficiently and with absolute impartiality."

Main Topic at Council Meetings Lately Seems to Always Involve Water

Water proved to be the main topic for discussion at the city council meeting Monday evening. Recorder Richey was instructed to communicate with S. A. Fredrickson regarding an open basement on his Angel street property filled with water, also, to charge water users the minimum price for one meter plus any overflow. Users in the past who have been billed various rates will be charged accordingly in the future.

Councilman Barnes reported a conference with E. Stipe in regards to water used by Stipes Garage which the city has never received any compensation.

In order that a definite action might be taken in securing a source of water supply, Councilman Hoswell suggested that the City Attorney be asked to investigate the law, furnishing the council with the necessary legal data, which would enable them to proceed without further delay.

Mr. Corey discussed the water problem, extending an offer to make a complete survey of the system for the city. The matter was taken under consideration. Mr. Olsen and R. J. Strausser Drilling company put in their request to bid on any well drilling the city might undertake to furnish the city with water. A report of the March audit of the Town of Beaverton's books was given by A. M. Amacher.

Mr. Cobb, our new attorney, was introduced by the mayor.

Attorney Myers informed the council they could expect an opinion from the bonding house attorney, in regard to the validity of the refunding bonds, within a short time.

The P. E. P. Company presented a new contract, which resulted in a motion from Councilman Barnes that the city reduce the size of candle power lights from 250 kw to 100 kw on all but the main traveled streets and that the electric company furnish a list of lights to be changed.

Street signs and fire hydrants were ordered painted. The hydrants are to be decked out in yellow and red.

A ballot taken for a councilman to fill the vacancy made by the resignation of Mr. Desinger resulted in the unanimous election of J. R. Talbert.

A brooder located in the orchard caught fire and destroyed 400 two week old baby chicks. The untiring efforts of the department saved 20 other brooder houses close by. Mr. Dudley had been using an oil burner in the brooder house and from all appearances the wind was the main cause of the fire.

BAND BOYS, FARM LADS PLAN MEETS AT O. S. C.

Oregon State college students and faculty are preparing to entertain two large groups of young people from all parts of the state going there for annual state high school band contest, April 15 and 16, and the annual state convention of Future Farmers of America, April 28 to 30.

The band contest, which in future will alternate between O. S. C. and the U. of O., will bring close to 700 musicians to vie for honors in the six solo contests and three band classes. Albany, Gresham and Irigoin are the three state champions at present.

The Future Farmer convention is the successor to the old "Smith-Hughes Weekend," which brought together students studying agriculture in high schools for a weekend of demonstrations and observations at the school of agriculture. Some 200 delegates are expected this year.

P. Zimmerman of Yamhill Out for Re-Election as Senator of Three Counties

Peter Zimmerman of Yamhill county has announced his candidacy for return to the seat he formerly occupied in the state senate from the district consisting of Lincoln, Washington and Yamhill counties. In setting up his position as a candidate he says, in part:

"There is a cancer gnawing at the vitals of our state and nation. Concentrated wealth is in the hands of the few.

"Our federal reports show that in 1929 504 people in the United States had net incomes greater than the combined gross income of all the wheat and cotton farmers of our nation.

"You cannot rub salve on a cancer and expect a cure, you must go to the root of the evil. In the very first place an extremely heavy income tax must be placed on the ability to pay, upon wealth, to provide for the immediate needs of our destitute people.

"The wealth of our state and nation is the result of the productive power of our people, and rightly belongs to our people. A handful of international bankers in Wall street have complete control of our credit system, and through the 20,000 banks in our country have enslaved our people. The only solution to our misery is for our people to assume full control of our credit and use that credit so we have free commercial intercourse between producers and consumers."

Candidates to Speak at Big Mass Meeting at Metzger Club House

Voters in the eastern part of Washington County will be given an opportunity to see and hear many of the candidates for offices in Washington County on Wednesday evening, April 13th, at the Metzger clubhouse, according to announcements of a local committee headed by J. O. Johnson. Considerable interest centers around the County Commissioner candidates because of the poor roads in this territory. A number of candidates have promised to be present. It is vitally important to the welfare of the people of the surrounding territory to attend this meeting which will begin at 8 p. m. in order that they may acquaint themselves with affairs of Washington County and know men for whom they are to vote.

County Judge Donald Templeton made a joint survey Wednesday with J. O. Johnson, of the roads in the eastern part of the county. Judge Templeton gave very favorable consideration for the immediate repair of several roads which are now in very poor condition and stated that work would begin after we have had 48 hours of sunshine. In reference to the Red Rock road over which there has been considerable litigation he stated that construction would begin immediately following the decision of Judge Walker which will probably be rendered the latter part of April. The construction has been held up for several years on account of injunction by one of the farmers residing along the road. He also stated that the eastern part of Washington county was entitled to more consideration in matters of new county roads and that he was very favorable to any reasonable request made by local citizens.

J. O. JOHNSON IN RACE FOR STATE REPRESENTATIVE

J. O. Johnson, prominent ex-service man and Tigard attorney, has formally announced his candidacy as State Representative from Washington County. Although Mr. Johnson is a young man his history and experience in public service is very interesting and qualifies him for the office he seeks.

He was born at Stafford, Oregon, in 1896. His grand parents on his mother's side, Mr. and Mrs. John Stalder, came from Switzerland, and settled at Bethany, Oregon, Washington County in 1875. In 1917 he



received appointment as clerk in the Bureau of International Revenue, Washington, D. C. After spending several months there he wired to Portland his enlistment in order that he would be able to serve from his state. He was then sent to Camp Pike, Arkansas, for training as an officer and was stationed there at the time of the signing of the Armistice. Returning to Washington he was transferred to the Federal Prohibition Bureau where he was put in charge of a division of clerks handling national statistics on federal prohibition and consumption of liquors. In 1925 when the Bureau was reorganized under General Andrews, he was executive clerk of the Department, handling civil matters pertaining to federal permits and taxes. He was given charge of the placing of 150 ex-service men and attorneys throughout the country when the bureau was decentralized.

In order to get back to the Pacific Coast in hopes of returning to Oregon he accepted the position of chief clerk of the new Federal Prohibition office located at Los Angeles. While in Los Angeles he was promoted to Associate Attorney, Bureau of Prohibition, handling all matters pertaining to collection of taxes and penalties under the Revenue Laws. In 1926 he was transferred to the Seattle office as Assistant to Wm. Whitney, Legal Advisor for the northwest territory. In 1928 he was transferred to Portland as legal advisor for the State of Oregon which position he held until 1930 when he resigned to take up the active practice of law in his home town. It was during the period that Mr. Johnson was legal advisor for the State of Oregon that two of the largest conspiracy cases were made. They were Joe Brown et al, and Case Bros., the latter operating one of the largest stills ever found in the State which was located at Six Corners.

In 1928 Mr. Johnson purchased the old Lehman farm near Metzger where he now resides with his wife and son. Mr. Johnson is a past commander of Kenneth H. Nash Post of the American Legion at Washington, D. C., and organizer and past commander of West Hills Post No. 66 of Multnomah, Oregon. He is a Junior Baseball Chairman and Legislative Chairman of District No. 1 of the American Legion at the present time. He is also one of the organizers and a member of the Board of Directors of the Tigard Lions club. He is a Mason, Knight Templar and Shriner, also a Director of the German Baptists Old People's Home, of Portland, Oregon.

Mr. Johnson received his LL.B. degree at the Washington Law School, and his Master of Laws and Master of Patent Law degree at the National University, Washington, D. C. In 1923. He was admitted to practice law in Washington D. C. He is also a member of the Bar of the State of Oregon.

Mr. Johnson states in his declaration that he will strive to pass fewer laws and give more thorough consideration to those that are essential. You may expect of him the application of diligence and common sense to necessary legislation. The last legislature attempted to pass 400 laws in 40 days which is too many,
