SEWAGE DISPOSAL REPORTED MENACE TO PUBLIC HEALTH

The Town Council met Monday at a called meeting, with Councilman Barnes, Boswell, Fordney, Koshland, Mayor Fisher, Recorder Wilson, Attorney Reimer, Water Supt. Goyt and Chief of Police Peets present. Councilman Livermore coming in later.

Minutes of a meeting held Friday evening, Dec. 8, were read and approved. At this time Mr. Forrester of Forrester and Lewis appeared before the council and asked that they be allowed to go ahead and prepare for funds to put in a sewer system, also that the council agree to submit the proposition to the people at a special election. His plan was for the project to be financed by revenue bonds, which would be paid entirely from service charges collected. The estimated service charges were considered too high to meet with the approval of the people and no action was taken.

Bruce Davis spoke in regard to the airport as a CWA project and he was asked to have definite figures and plans to submit at the next meeting.

Mr. Koon and Mr. Cunningham, engineers were present at the Monday meeting to answer any questions in regard to their report on the proposed sewer system.

The following communication from the Oregon State Board of Health was read: Motion by Boswell seconded by Fordney that said communication be spread on the minutes. The vote was: Yeas, 4, Barnes, Boswell, Fordney, Koshland; Nays, 0. Absent, 2, Bishop and Livermore.

Mr. Earl E. Fisher, Mayor, Beaverton, Oregon, Dear Sir: In response of your City Recorder's request of December 7 that an investigation be made of the methods of sewage disposal in your city, he advised that Mr. Green, our sanitary engineer, made an inspection on December 9. He found that the present storm water sewer system is being used for the disposal of sanitary sewage as well as storm water. In most cases the sewage is passed through septic tanks before it is emptied into the storm water sewer. However, it is possible that in a number of cases raw sewage is discharged into the system. No doubt many of the septic tanks are overloaded and improperly maintained so that they are of little value in treating the sewage. The present methods of disposal in your town are unsanitary, cause nuisances at times, and are a menace to the public health. The remedy in this condition lies with the city. It should construct a sanitary sewer system to collect and properly dispose of all sewage from the city. We urge that this be done. Very truly yours, Frederick D. Stricker, State Health Officer.

Bruce Davis was present to give further information in regard to the airport as a proposed CWA project. The Recorder was instructed to place the application of Mr. Skee for the endorsement of the Town Council as storekeeper for a State liquor store in Beaverton, if there is such a store, on file as application No. 1. The request of Mr. Skee was taken under advisement by the council.

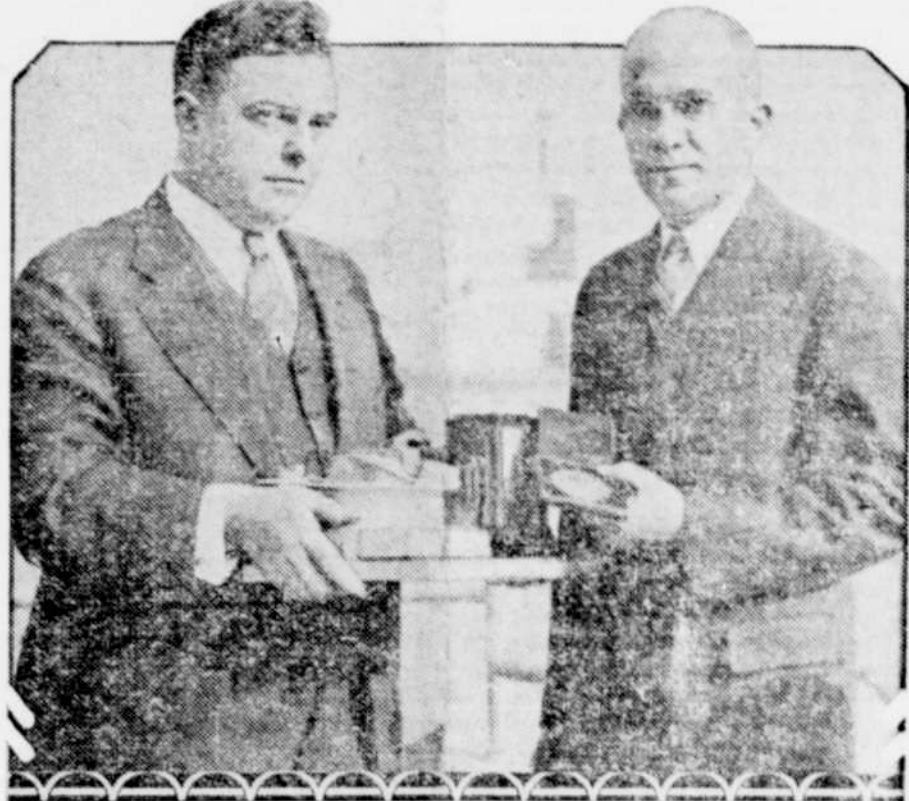

County Agents Office to Inspect Holly Shipped

Holly that is to be shipped thru the mails or sold may be brought to the county agent office at Hillsboro, Monday, December 18, for inspection, says Mr. Cunningham, a representative of the state department of agriculture, who will be present all day Monday to make such inspections. This inspector reports that he has not detected any scale on the holly in this part of Washington county but says this does not mean that it may be shipped without inspection. It must be inspected and Monday has been set aside for that purpose. Anyone having even a small quantity should bring it in on that day, not the day before or the day after.

W. F. Johnson Explains Clean-up Method for Pullorum Disease

Nearly fifty members, parents and leaders attended the county-wide poultry meeting in Hillsboro last Saturday. Dr. W. T. Johnson, poultry pathologist from Oregon State College, conducted the meeting and talked about disease control and poultry sanitation. Special emphasis was laid on the control and clean up methods for pullorum disease. This disease, Dr. Johnson said, can be 100% controlled and eliminated by doing away with carriers. He explained the method of locating carriers in the flock and showed how to draw the necessary blood samples. To strengthen the demonstration, three of the older club members actually drew samples from birds. Precautions against introducing this disease into a clean flock were explained.

Dr. Johnson showed the group the proper method to handle birds for examination and treatment. He demonstrated the procedure in vaccination for fowl pox and emphasized the management practices involved in control of round worms and tape worms which consists largely in removing contaminated litter before the worm eggs hatch and keeping the growing stock on a clean range. Prevention of coccidiosis and treatment for lice and mites were discussed.

This meeting is the 1st of four county-wide meetings, according to Joseph Belanger, assistant county agent. Meetings are planned to augment the regular work of the 4-H poultry clubs and place the same information before the parents which the club members are getting.

Summary of Dr. Johnson's talk will be sent to the club leaders with a list of questions covering the material discussed, Belanger said. The next meeting will come in February and will cover the general subject of selection of eggs and chicks, incubation and brooding.

Two Poultry Meetings Scheduled for December

December poultry meetings for Washington county will be held at the Forest Grove Chamber of Commerce rooms, Wednesday evening, December 20, and the Beaverton High School, Thursday evening, December 21. Both these meetings will begin at 8 p. m. A. G. Lunn, head of the poultry department at Oregon State College, will be present at both these meetings, says county agent Wm. F. Cyrus.

11 LOANS IN COUNTY CLOSED

The total amount asked for in the 97 applications is \$291,100. Of the 97 written 31 have been approved by the bank and 45 are under consideration.
