Our "Front" in European War

Babson Makes Plea for U. S. to Aid Allies

Washington, D. C., June 21—It now must be clear to every American that Hitler stands for **WORLD DOMINATION**. The United States suddenly finds herself in a desperate position—caught between Allied Canada and unstable Mexico. New methods of warfare are being home to us the startling precariousness of this position. Until the advent of the bombing plane, isolation was a wonderful theory. Today, this concept, like neutrality and international law, is as dead as a door nail. A pack of wild animals are roving the world. To protect America, we should immediately give the Allies credit and all our available material.

To be realistic, the question today is not how shall we get into the war—but how shall we get out of it? Do we choose to fight on American soil or choose to fight on foreign soil? The line between defense and participation is becoming thinner and less distinct every day. Back in 1919, we were sure that we had fought for a right cause. The Imperial German Army differed from the present Nazi Army only in that it was less diabolical, less brutal, less ruthless. Twenty-five years ago we joined the Allies to save the world for democracy. We believed that we were right and I am sure we were.

Too Kind or Too Harsh?

Our great mistake was in underestimating the viciousness of the Russian mind. Lloyd George and President Wilson counseled against a "March on Berlin." We thought kindness would win the German people to our side. We failed to reckon with human nature, however. At the Peace of Versailles, the kindness of sparing Germany was offset by the desire of certain of our Allies to rob the German of their ability to earn a living. Hence, either we made a mistake by not being harsh enough with the Germans in 1918 or by being too harsh with them in 1919!

However, our intentions were good. We spent \$60,000,000,000 to help the Allies and the cost is still multiplying. Thousands of Americans were buried in Flanders Fields; hundreds of thousands more were permanently disabled. These lives and this money were spent on a cause that was sound and right. Summer Camps Schedule Given

American youth throughout the country is beginning summer vacation this month and joining in the camping programs of the various youth groups in their districts.

The Portland Community Chest sponsors over seven organizations in Oregon including four girls' camps and three boys' camps which are ready to open soon.

One of the largest is Camp Meriwether for the Boy Scouts. This camp, located on the Tillamook coastline in a wooded retreat, will open June 19 to operate until August 21.

Camp Meehan, big Y. M. C. A. camp at Spirit Lake, Washington, will open its 32nd year July 1 to run until September 1.

The B'nai B'rith camp at Neetsu will open June 23 to operate until July 27 for boys. On July 28 the girls will take over the same camp and use its facilities until August 17.

Camp Namanu, the Camp Fire Girls' camp opens June 20 for ten weeks.

Camp Wildwood has made recent additions to its already very complete equipment for a camping period from June 23 to August 19.

Boys and girls who attend these camps will be under trained leaders whose duties will include "teaching the traditions of American self reliance and individual initiative," according to Grace Lowers, chairman of the boys and girls sub agency of the Community Chest.

Entries for the general landscape effects section close July 1st. This is a part of an enterprise designed to establish the Portland area as the Flower Garden Capitol of America. An ambitious judging schedule has been arranged and awards will be given in the following classes:

- 1 Landscape effects.
- 2 Lawns.
- 3 Flower and shrub borders.
- 4 Dahlias.
- 5 Gladiolus.
- 6 Chrysanthemums.
- 7 Hobby gardens.
- 8 Water features, pools, etc.

Many subclassifications are listed to take care of all sizes and types of yards and gardens. The public is urged to enter the contest even if you think your yard is too small or feel that it is not good enough to win a prize, enter the contest anyway.

The judges' comments on your garden and their suggestions for its improvement based on its individual location and characteristics, will be worth more than the entry fee. You also might fool yourself and win a prize.

The entry fee for class 1—Landscape as a whole is 50 cents. As stated entries for this class will be closed July 1st as all entries will be judged twice this year, in summer and again in the fall.

All other classes will be judged once and entry fees will be 25 cents for each entry.

The Multnomah Garden club has been designated by the Metropolitan association to inform the public of details of the contest and take entries. Blanks may be gotten at Mrs. Ben Gelach's home next to Multnomah school.

Molalla, Oregon, June 21—Molalla citizens are "dressed up" for the 17th annual Molalla Buckeroo scheduled for July 4, 5, 6 and 7. Boosters of the big roundup are wearing 10-gallon hats and brightly colored shirts for which this western city is well known.

Plans for the roundup are materializing rapidly and directors of the association have announced that all Boy Scouts bearing credentials will be admitted for 25 cents on Friday, July 5. Special features for the youngsters will be provided this day. Nationally known cowboys are sending in their entry blank, competition to be furnished by wild horses from eastern Oregon, ferocious Brahma steers, Texas longhorns, and speedy calves. The "king" of the Brahmas is "Speedy" the big bull who has not been ridden for three years. The Molalla Buckaroo association has offered a \$50 special prize to any cowboy who rides him during the show. "Sleepy" just can't be tamed. He is in all kinds of trouble last year and nearly wrecked the roundup fences and corrals.

Supt. Williams Reports Increase in Offerings

Oklahoma City, June 21—Nazarenes increased their benevolent giving 51% to a total of \$18,000,000 during the quadrennium, it was announced last night by Dr. R. T. Williams, in the Quadrennial Address for the Board of General Superintendents at the Tenth General Assembly in Oklahoma City's Municipal Auditorium.

The Church holds first place among the 25 leading denominations in per capita, giving having averaged more than \$39 per member for each of the four years.

The report showed an increase of 24% in church membership, to a total of 172,144. The membership doubled in a decade, having been 81,000 in 1930.

In this quadrennium 362 new congregations have been organized in this country and seven old nations opened in foreign lands.
