Gasoline Registration Set Ahead to November 18-20

The office of price administration Tuesday postponed nationwide gasoline rationing from November 22 to December 1.

At the same time OPA regional administrators were authorized to delay school house registration of motorists from November 12-14 to November 18-20.

OPA officials said the postponement was necessitated because war-time transportation congestion made it impossible to deliver the more than 300,000 pieces of printed matter necessary to put the program into effect by November 22.

The war production board it was learned authoritatively on Tuesday night, has decided on a further drastic curtailment of fuel oil for the eastern states this winter.

Although oil already is being rationed in the 17-state area on the basis of holding interior temperatures at 65 degrees in most cases, the board found that present transportation facilities could not deliver enough oil to fill the allowance.

Hundreds of volunteer workers, both men and women, will be needed to process applications for supplemental gasoline under the rationing plan which goes into effect, nationwide, December 1st, Cameron Squires, state organization officer of CPA, said today.

These volunteers will work at the local war price and rationing boards from 7 to 10 p. m.

The volunteers who will work with the boards will be known as the Advisory Transportation Panels and they will pass upon the requests for supplemental gasoline and decide whether the applicant is entitled to a B or C book and the mileage to be rationed to each applicant. The applicants will have the right of appeal to the board, also to the state OPA office and even to OPA in Washington if he feels he has not been rationed the mileage he is entitled to.

All volunteers willing to serve on the Advisory Transportation Panels are asked by Squires to register with their county civilian defense office or coordinator.

City Council Passes Dim-out Ordinance

Beaverton City Fathers met Monday night to consider monthly expenditures and passed two ordinances, one dealing with the dim out problem and the other in regard to the matter of parking cars in the business district.

The dim out ordinance provided a minimum fine of \$10 and a maximum fine of \$300 for violation. A complete blackout must be made according to the rules laid down by the government. If in doubt anyone can call the city hall, J. J. McMahon or the air raid warden and they will advise you on your particular problem.

The traffic ordinance designates where cars can be parked, some on only one side of street, a place will be blocked out for buses to park when unloading or loading passengers, etc. Everything will be plainly marked on the pavement and stop signs will be placed where needed. J. H. Smith will have charge of this work.

E. H. Masters Re-nominated Beaverton's Mayor

Postoffice Department Asks Early Mailing

The Post Office Department now is starting the most gigantic task in its history—the movement of a deluge of Christmas parcels, cards and letters while maintaining the regular flow of millions of pieces of mail daily to our and from our armed forces all over the world.

Indications are that the volume of Christmas mail will be the largest on record.

If thousands of our soldiers, sailors, marines and civilian friends are not to be disappointed at Christmas time, the public must cooperate by mailing earlier than ever before and by addressing letters and parcels properly. The best efforts of the Post Office Department alone cannot be enough, in view of wartime difficulties faced by the postal system. The public must assist.

About 25,000 experienced postal workers already have been taken by the war services. Arrangements are under way to add thousands of temporary personnel to postal staffs, but this man power is hard to find and is inexperienced. Facilities of railroads and air lines are heavily taxed by movements of huge quantities of war materials and personnel. Extra trucks are almost impossible to obtain. Winter weather, hampering transportation, is beginning.

The Post Office Department is making strenuous efforts to avoid such a terrific jam as it faced in 1918 under similar conditions, during the First World War. It can succeed in those efforts—and avoid many heartaches for its patrons—if the public will cooperate by mailing early.

Many communities are realizing this and are expressing the solemnity of inauguration day by using the oath which was taken centuries ago by the young men of Athens when they became of age.

In this time of war, when like the Athenians of old, we are fighting against the savage barbarian to preserve a democratic way of life, this oath should not only be made by those about to take office but by every one of us. Let us repeat it together.

We will never bring disgrace to our city by any act of dishonesty or cowardice, nor ever desert our suffering comrades in the ranks. That is, we will be honest and courageous in all our dealings with our fellow men, regardless of class, race, creed, or color. We will not shirk—we will work and fight and pray for the good of the whole nation and we will not allow prejudice or intolerance to deter us in any way from our task.

"We will fight for our ideals and sacred things of that city, both alone and with many." That is, while we fight the enemy without with all our force, we will keep alive the spirit of democracy and freedom for all, which is the guiding light of our republic. We will not compromise our ideals.

"We will reverence and obey the city's laws and do our best to incite a like respect and reverence in those about us who are prone to annul them and set them at naught." That is, we will not only keep the laws of our community in the letter of the word, but in the spirit as well. We will keep our community free from subversive influences which attempt mental sabotage against our institutions and ideals, and we will teach to the younger generation reverence for the high principles which govern our Constitution and which guide us as a nation.

"We will strive unceasingly to quicken the public's sense of civic duty." That is, we, by taking our part in all activities for the preservation and protection of the community, will act as an example to others, encouraging them to join in work not for themselves alone, but for all our people.

"And thus, in all these ways, we will strive to transmit this city not less but greater, better and more beautiful than it was transmitted to us." Our duties as citizens are not only to ourselves and our neighbors, our community and our nation, but to those who follow. The only way we can pay our debt to those who bequeathed to us a free way of life is to pass on to subsequent generations a free nation, united in devotion to the cause of liberty, better and more beautiful because of that unity. Thus it came to us.

National Grange Session Opens At Spokane

Far-reaching interest always attaches to the annual convention of the National Grange, America's oldest and largest farm organization, because its membership is of a bona fide character and because it voices the earnest convictions of rural people. The Grange is 75 years old, has weathered many a financial and political storm, and today is stronger in membership and assets than ever before, holding the respect of the entire nation because of its invariably sane program.

The Wenatchee session opened November 11, and the keynote address was the annual message of National Master Albert S. Goss, a recognized farm leader with wide experience along agricultural, cooperative and financial lines. As Federal Land Bank Commissioner for several years, Mr. Goss' work was outstanding, while few men in the United States have been so closely connected with agricultural and cooperative undertakings. He therefore spoke for the farm people of America when he addressed the Wenatchee session, and his message is unusually informative.

First emphasis is placed by Mr. Goss on the supreme task of mobilizing all forces for the winning of the war, and to this end he pledges the united efforts of American farmers, with the Grange everywhere taking its stand behind a unified war program.

In equally stern language Mr. Goss warns of the grave national danger in the apparent trend toward centralization of power, whose results may be the destruction of the very principles of democracy for which we are now so bravely fighting.

Preservation of the freedom of the press and of the right of criticism of methods of government are also stressed by Mr. Goss as now threatened. In plain language he warned America of an impending food shortage unless speedy recognition is taken of the dangerous situation of the farm labor situation, with immediate steps for effective correction.

Equally impressive is the warning of the National Master against the continued use of government subsidies to bolster up agriculture; summed up in these significant words:—"One of our worst dangers is that in striving to benefit agriculture attempts may be made to make an unsound system work by the use of subsidies, thus passing the burden of our mistakes on to future generations."

Naturally the portion of the National Master's address to receive closest scrutiny is his analysis of the farm problem and his views concerning its solution. Declaring that "instead of a problem of surplus, we now face a problem of maintaining ample production," Mr. Goss warned against such a coming collapse of farm prices as followed the last war, and at the same time indicates the possibility that if present labor conditions continue this nation will face the gravest danger of not being able to produce sufficient food to meet the demands coming from every side.

Mr. Goss discusses at length the subject of price control and concludes in the words of the Grange declaration on farm prices:—"Farmers should not ask more nor agree to accept less than actual parity, but it is essential that a just rule be provided for determining parity." He then explained very completely the parity basis of 1909-14, but points out how completely it has been upset by changed conditions; especially the fact that farm labor must now be included if anything like a fair parity basis for farmers is to be secured. National Master Goss searchingly analyzed the withholding of legitimate news from the people and the attempts to bribe or limit the American press. He points out that of the American people to know what their government is doing, as well as to be protected against vicious propaganda which may endanger a nation's morale, both in times of peace and war.

National Master Goss brought stern facts fully to the surface when he reminded America that our enemies are working half their people in war industries and holding them to 60 and 75-hour working weeks, while the United States still clings to the 40-hour week in industry, with time-and-a-half for overtime—all in the name of "preserving our social gains."
