Canyon Road, Zone 1, Oregon and endorsed "Proposal for Water Supply Improvements, West Slope, Water District", will be received at the office of the District at West Slope until 8:00 P. M. Pacific War Time on the Fourth day of April 1945, and thereafter will be publicly opened and read. Award or awards will be made at a meeting of the Commission to be held at 8:00 P. M. P. W. T., on the Sixth day of April 1945.

The proposed work consists of furnishing and installing a 12" I. D. water supply line from the Portland City water supply system along Canyon Road and extending to the District's 100,000 gallon steel storage tank; and the installation of feeder and distribution mains within the water District. The distribution system work includes the laying of primary feeder mains, the bulk of which are 12" I. D., some of which is to be 14" I. D. as well as some 8" and 6" distribution mains. The 12" supply line is to be placed in a trench now occupied by a 6" O. D. steel pipe line having dresser couplings; and water service is to be maintained by keeping the present 6" supply line in service on top of the ground during the installation of the new supply line.
