# Our Drivers Make \$3877.75 a Year

*Yet union representatives threaten a strike...  
in the face of our offer of peaceful arbitration*

**L**AST THURSDAY we were surprised to read a newspaper story announcing that the union covering our drivers and shop employees was preparing to strike.

Recognizing our continuing responsibility to the public, we believe YOU are entitled to the facts.

On October 29 the union cancelled their contract with us, effective January 1. Since then we have made every effort to reach an agreement. Twice we accepted proposals which the union's spokesmen told us would meet the demands of our employees. Both times these same union spokesmen returned with increased demands.

When they returned the third time with an ultimatum of further increased demands, strike or arbitration, we accepted their own theory of arbitration and proposed to lay the entire matter before any impartial umpire or board. We felt nothing could be fairer. We do not know whether this proposal was ever presented to our employees.

We have offered cost-of-living wage increases which would mean that our drivers would earn an average in excess of \$4000 a year. Last year the average pay checks for the 79 Oregon Motor Stage drivers totaled to a healthy \$3,877.75 for a full working year of 52 weeks, including two weeks vacation with pay!

Our offer to arbitrate the entire matter stands. If there is an interruption in our services it will be in face of this fairest of possible offers.
