PUBLIC MARKET Plans Submitted by the Union Market Co.

The public market block proposition was thrashed out before the Judiciary Committee and Board of Public Works and individual members of the Council at the City Hall at 2 o'clock this afternoon.

Attorney C. W. Miller appeared in behalf of the Union Market Company and submitted plans, etc., in support of the lease asked for. Attorney J. J. Johnson represented the Grange of Multnomah, Clackamas and Washington Counties, and protested against the city leasing the old exposition to a private corporation at present. He said that the large farming community adjacent to Portland should be given ample time to look into the matter. He referred to letters received from Baltimore and other cities of the East, giving information about markets. Baltimore maintains 11 such institutions, and the profits from them last year amounted to over \$50,000.

Attorney Miller said he had no fear about his being able to give a good account of his company and proceeded to lay out the plans in detail. In consideration of the city giving a lease of the block bounded by Second, Third, Clay and Market streets for a period of 10 years the company will within 30 days commence the improvements. The buildings will be fashioned after those of Baltimore, pictures of which were exhibited.

The main building is to be 65x13 feet; the center structure to be 20 feet high to joists. The building is to rest on concrete piers, frame work to be of substantial timbers, the walls to be of rustic, with windows on both sides, the entire length of the building. The roof will be shingled and the floor made of wood. Two additions, 12½ feet by 20 feet, will be erected.

There will be a structure 14x50 feet on each side of the main building fronting Clay and Market streets. The sides and ends will be open to allow teams ingress and egress.

A walk 14½ feet wide will extend from street to street, through the center of the block each way; also a roadway 17½ feet wide between side structures and main building, running from Second to Third street. All ground space, except that enclosed by the main building, will be paved with asphalt.

The plans and specifications will be submitted to the City Engineer before work is commenced.

At the expiration of the 10 years the company, upon request, will surrender to the city the block, buildings and improvements, without cost, in consideration of the free use of the block for the period mentioned.
