

RAKE-OFF

That Furnish Got From Government.

The "Man of Action" Knows How to Charge.

Banker Furnish is a self-made man, a "man of action," who knows how to get along in the world. No one is going to deny this. It is accepted as a statement of fact.

Banker Furnish showed to good effect how much a man of action he could be during the time he held the position of Deputy United States Marshal in the years 1888-9, under John Myers, with headquarters at Pendleton.

During that period the "whisky-to-Indians" business grew to such proportions that the position of Deputy United States Marshal at Pendleton was regarded as a particularly soft snap. Through the connivance of an organized gang at Pendleton, "whisky-to-Indians" cases occupied most of the time of the United States Court in Portland.

It was a bonanza to those on the inside, and no one knows how much was made out of the numerous cases worked up by the industrious Federal officials at Pendleton. But what the record does disclose shows Banker Furnish had a comfortable rake-off during his two years' service as Deputy United States Marshal. His fees in compensation for the time he held his profitable position amounted to \$9651.94.

At that time the office of United States Marshal was run on the fee system, and deputies were allowed to retain 75 per cent of all the fees and emoluments they worked up.

Out of this amount they had to pay their expenses, but, as a matter of fact, these were nominal. Railroad fare between Pendleton and Portland was charged up at the rate of \$46 per fare each way. The actual fare was \$25. But the deputy either had a pass over the road, else had the advantage of the "stand in" that prevailed at that time, and the railroad company was lucky if it got even a fair division of the fares.

The "whisky-to-Indians" cases were worked up to such a degree of success during the time Banker Furnish was the deputy at Pendleton that they grew into a public scandal.

Banker Furnish enjoyed the fruits of the nefarious business unchecked, but the example set was later followed by other Pendleton deputies with such persistence that Judge Bellinger took a decided stand against the iniquitous business, which proved the undoing of one United States Marshal and his deputies, and brought to an end the disgraceful scandal that found its origin when Banker Furnish was introducing to the people of Oregon his first imitation of how a "man of action" looks after once getting fairly down to his work. Here is the record of his compensation for two years of service:

DENOUNCED PRESIDENT

Probably Roosevelt Never Before Received Such a Tanning.

SAVANNAH, Ga., May 5.—"The recreant son of a Southern woman—the rough rider of Republican politics—and the lightning change artist of the White House," were among the compliments handed to President Roosevelt by the Rt. Rev. Benjamin J. Kelley, Catholic bishop of this diocese, before the Confederate veterans of the war in his Decoration Day address.

The speaker declared that Jefferson Davis was a man of high character, put in office by ballots, while Roosevelt was made President by a bullet.

The executive's praise of Southern heroes, after "sitting cheek by jowl with an Alabama negro," was held up as a hypocrite.

The bishop's address was upon conventional lines until near the end, when he said, after paying a tribute to the memory of Jefferson Davis:

"It is true that the gentleman who now happens to sit in the presidential chair at Washington has written of President Davis:

"Before Jefferson Davis took his place among arch-traitors, etc. It was unnatural that to dishonesty he should add treachery to the public. The moral difference between Benedict Arnold on the one hand and Aaron Burr and Jefferson Davis on the other is the difference between a politician who sells his vote for money and one who supports a bad measure to get a high political position."

"When Mr. Davis was living and a prisoner a fellow named Miles placed shackles on him in prison, though there was no necessity for it, and no one but a brute would have done it. But I have never heard that Miles, after Mr. Davis' death, maligned his character. That speaks of venom was reserved for the recreant son of a Southern woman—the rough rider of Republican politics at the rough rider of the lightning change artist of the White House, who can hobnob with the Kaiser's brother and sit cheek by jowl with an Alabama negro; who can indulge in meaningless platitudes while South on the bravery and common heritage of Southern heroes and denounce them before the Grand Army of American spirit which brands sectionalism as a crime and laud the loyalty of our veterans of 1861-65 to the constitution and reunited country, while the damning evidence of his own written word shows that he compared 'the noblest Roman of them all,' Jefferson Davis, to a Benedict Arnold."

"The revolutionary, unconstitutional and subversive tendencies of the abolition or Republican party are as evident today as they were 40-odd years ago. This sniveling and Pecksniffian hypocrisy with regard to Cuba—which they intend to annex—is only surpassed by their atrocious treatment of the Philippines, on whom they are forcing a system which the people do not desire."

"They have sought to degrade us by placing our former slaves on a political level with us and fostering such on us as federal officeholders. The present occupant of the chair of Washington, Jefferson, Madison, Jackson, Tyler and Cleveland—is familiarly and properly known by the sobriquet, 'The Rough Rider.' His only claim to future fame or notoriety will be, I sincerely trust, that he broke up the Republican party."

"But on the war and its issues we do not wish to be misunderstood. We have nothing to retract; nothing to apologize for. We are bearing our share of the burdens of our country without a murmur. We have not profited, I fear me, much by the lessons taught us by the yearly increasing legions of patriots in blue, who 37 years after the war yet manage to drag their weary bodies to the pension office and draw \$10,000,000 from the treasury."

"Our ideas of patriotism do not seem to be of the same order. But we have set apart a day to recall the memories of past and drop a tear over the graves of our heroes. From our poverty we have raised modest shafts in village and city all over the South which tell in language better than e'er fell from human lips how we treasure the memory and honor the brave deeds of our own."

UMATILLA FOR CHAMBERLAIN

Cheering News From Eastern Oregon.

(Journal Special Service.)

PENDLETON, May 5.—The Democratic central committee of Umatilla County is engaged in the preparation of a complete poll of the county and expect to complete it within a few days. This poll will be accurate and will show the status of the local voters as to the state candidates. Chairman Stillman has the work in hand, and will see that it is thoroughly done. He was asked today to give to The Journal a statement officially as to the probable outcome of the poll. He replied:

"Although the work is yet in process I am certain that it will show that the county will be safe for Chamberlain, inasmuch as it is incomplete, I would not anticipate the final figures by giving estimates at this time. I noticed in the papers the assertion the other day that the Umatilla people had themselves made a poll of the county, and I found that the Republicans will vote for Chamberlain. This is cheering news, and I trust that our poll will show that it is true. In general, the situation here in Umatilla County is excellent for the Democratic ticket. Enthusiasm is manifest on all sides, and every Democrat, so far as I know, is in line for Chamberlain and the other state nominees."

Raley Strong at Home.

There is one fact that is accepted as going without the saying, and that is that Colonel James H. Raley, candidate for Attorney-General, is going to make a splendid run in this part of the state. His fine record and high standing, coupled with his personal popularity, will bring to him support from all Eastern Oregon counties. Every county east from the Cascades will roll up a majority for Raley that will send him down to Multnomah County with a handsome lead, and it is understood here that he has fine support down there. Reports coming here to personal friends say that in the Willamette Valley Raley is making the run of his life. He was in the State Senate for eight years, and made a record that won friends and admirers everywhere.

Blackman Running Well.

Henry Blackman, nominee for State Treasurer, is surprising even his friends who were confident that he would be a strong candidate. He has numerous supporters throughout the Eastern part of the state, and they learn of daily increase of strength for Blackman among the voters. From the Cascades to the Nevada and Idaho lines he is looked upon as a winner.

Butcher's Vigorous Campaign.

Colonel Butcher, who was named for Congress from the Second district, is gaining ground every day. His campaign parades of some especially strong features, which take their rise in the combination that was formed between Furnish and Williamson whereby old-line Republicans were turned down, and refused even the privilege of going to the state convention, in cases of men who were anxious to support the nominees that were finally selected by the conventions.

That Vest Pocket Delegation.

In this connection, it is stated that one reason why the old-line Republicans are so angry in that Furnish, as he formed his plans, determined that no one could go from this county unless he was willing to be a member of a "vest pocket" delegation, a delegation every member of which was willing to deliver over to him the absolute control of every action and move, and also pledge himself to be traded as Furnish saw fit.

Some of the wheel horses resented this demand, and asked that they be allowed to go upon their own promise that they agree to support Furnish, and have some liberty as to other matters that might come up. The "vest pocket" rule was enforced, and not a man was permitted to go to the state convention from Umatilla county unless he was owned body and soul by Furnish.

Improved Train Service.

Yesterday the Northern Pacific Company inaugurated its improved train service. It has put on four trains between Portland and Tacoma and Seattle. The demands have gradually increased from a single train daily to two, three and now four, showing the immense increase in business. These trains in order are: The through overland to Kansas City and St. Louis, via the Burlington, leaving Portland at 3:25 a. m. and arriving at Portland at 11:10 p. m.; the Puget Sound Limited, leaving Portland at 9:25

It Galled Them All.

Lukewarmness on the part of men who have always been depended upon to carry this county for the Republican party is what will bring defeat to Furnish here and elsewhere.
