

SIXTH WARDERS IN SESSION To Ratify Citizens' Nominations and Hear Speakers.

Rain did not dampen the ardor of the enthusiastic supporters of the Citizens' ticket residing in the Sixth Ward, last night, and Terwilliger hall was crowded to its fullest capacity.

The Sixth Ward has always been regarded as the Republican stronghold in Portland, but it will be different next June. Ring rule has reached its limit in the minds of many who formerly supported the Republican ticket without question, and the enthusiastic manner in which all the speakers at the Sixth Ward meeting were received last night showed that there would be many independent voters cast in the old reliable Sixth at the coming election.

R. D. Inman, Citizens' candidate for Mayor, was a late comer, being delayed by business, but his appearance was the signal for an ovation that showed how popular a man he was among all classes of people. Dr. Harry Lane, Citizens' candidate for State Senator, arrived after the meeting was in progress and as he worked his way through the crowd a storm of applause greeted him.

GOOD HUMOR PREVAILLED. The meeting was the best held in the Sixth Ward for years. Every one present was in the best of humor and after the singing of several songs, John Manning, acting as chairman, called the assembly to order and introduced W. Y. Masters, Citizens' candidate for Councilman to represent the Sixth Ward, as the first speaker. The remarks of Mr. Masters were short but witty and to the point. Robert J. O'Neil, Citizens' candidate for Justice of the Peace, and one of the Second Oregon boys who followed the flag to the Philippines, was given a special reception and made a good impression. He did not confine his remarks to his candidacy, but spoke earnestly in behalf of the Citizens' ticket as a whole.

G. C. Moser, candidate on the legislative ticket, stirred up the enthusiasm of all present in a short but effective speech in defense of the Citizens' movement, and his arraignment of the methods by which the machine ticket was gotten up. J. E. Werlin, candidate for City Treasurer, was at home, and the applause that was given to him showed how well he stood among those who knew him best, and was a fitting testimonial of the high appreciation in which he was held.

POPULARITY ATTESTED. Dr. Harry Lane and R. D. Inman were the next speakers, and the cordial manner of their reception attested to the popularity of both. Dr. Lane always has something new to say and what he has to say carries weight with those who listen to him. He is growing in strength every day and proves himself a formidable candidate against his antagonist on the ring ticket, whose election was first claimed as something "dead easy," but now the strongest supporters admit only the possibility of success.

There is something in the individuality of R. D. Inman that wins him new friends and stronger support each day. He is an ideal candidate for the responsible place of chief magistrate of Portland. He makes no claim of being an orator, but his level-headed, straightforward views of the duties of Mayor, combined with his well known honesty and integrity, and hearty recognition with all classes. He is a representative man, and as one admirer of "Honest Bob" said last night, "He's always the same in spite of clothes or overalls." That was an unconscious tribute to Mr. Inman, but it reflects the sentiment of thousands, particularly those of the working classes, whose friend he has always shown himself to be.

Not the least attraction of the meeting last night was the presence of Frank D. Hennessy, who favored the large audience with a number of songs, singing as only Hennessy can sing, every one of which brought down the house.

POLICE RECORD.

Eugene Buchanan, a boy, was fined \$5 today for damaging rubbish on property under charge of C. K. Harbaugh. L. L. Carter and Frank Woodman, contractors, each charged with erecting buildings in different parts of town without first procuring licenses, were up in the Police Court today, but had their cases continued until Monday. Judge Cameron yesterday held Walter Wyman in the sum of \$500 to appear before the grand jury for attempting to rescue a prisoner from Officer Carpenter recently. E. F. Morefield, under arrest for embezzling \$200 from his employer, George Woodworth, was to have had a hearing today, but the state was not ready to proceed, so a continuance until Monday was taken.

Contributed Liberally.

T. B. Wilcox has the honor of being the only Portland man, so far as known, to contribute to the relief of the Maritigue sufferers. Shortly after the disaster he was sent a telegram by the New York World, asking him to make a donation. He did so immediately, sending \$200 by wire. He supposed that other citizens had also received the same request, but so far as known no one else in Portland has been asked to contribute to the relief fund.

FEDERATED TRADES

Weekly Meeting of the Council Held Last Night.

It was decided last night at the Federated Trades Council to extend every possible assistance to the striking planing mill employees of this city and to the woolen mill strikers at Oregon City. Methods to assist them were discussed at length, and it was decided to place an immediate boycott upon the mills.

Several resolutions were referred from the state federation. One of them was regarding the Portland City and Oregon Railway, but since the employees of that corporation have been allowed to become unjoined, no action was taken on the subject.

The second resolution had reference to the unloading of freight at other than terminal points, in this manner taking work from teamsters who otherwise would be employed. In hauling it from mills at that place reported that the object of the visit was not attained. It was also given out that a large mass meeting will be held at Oregon City Monday and that many delegates from Portland will attend. The strikers will be encouraged to continue their attitude and will be given assistance from local unions.

The new card presented by the Bar-tenders' Union was endorsed. In order to receive union patronage the saloons will have to exhibit this card.

The committee which had visited Oregon City with the view of endeavoring to adjust the differences existing between the employers and employees in the woolen mills at that place reported that the object of the visit was not attained. It was also given out that a large mass meeting will be held at Oregon City Monday and that many delegates from Portland will attend. The strikers will be encouraged to continue their attitude and will be given assistance from local unions.

The committee which had been appointed to visit the planing mill proprietors and try to adjust differences reported that it had accomplished nothing, and the matter was referred to the Building Trades Council, which meets next Monday. When this body passes upon the matter, all union men affiliated with the building trades will refuse to handle material from the unfair mills.

The excursion committee reported that active preparations are being made for the excursion to the state capital June 1, and that many prizes had been donated for the various contests to be given there at that time.

Members of the Amalgamated Wood-workers' Union will give a grand ball at an early date, the proceeds of which will go to the strike fund.

LILLIAN FELLOES' WILL.

The last will and testament of Lillian Augusta Fellos, deceased, filed for probate today, makes the following bequests: That the personal property be converted into cash and that the estate be distributed as follows: To William Barrington d'Almeida, \$250; in the event of the father dying before the testator, a sister, Ross d'Almeida, is to receive it; to Marcellus d'Almeida, a brother, \$250, with the same provision as bequest just mentioned; to the children, all the personal property, in equal shares, and the residue of the estate, in equal shares, to be held for them in trust by the father until he becomes of age; to the husband, Edgar Fellos, one-half of the property in money not otherwise disposed of; if the husband marries again, his share shall revert to the children. Marion d'Almeida is named as the executor.

NORTHWEST NEWS

PORT ANGELES, Wash.—Mrs. Tillie E. Riley has been found guilty of perjury here after three trials. She swore falsely against Joseph Priest, charged with rape.

SPOKANE, Wash.—The Democrats, for the first time in six years are in full control of the city government here.

SEATTLE, Wash.—In a debate between the Universities of Washington and Oregon here last night on the 15th amendment to the Constitution, Oregon upheld the contention that it was justified, won easily. Seattle men were judges of the debate.

THE WEATHER.

General rains have fallen during the last 12 hours in the North Pacific States, and the weather west of the Rocky mountains is unseasonably cool. It is moderately mild in the Middle West, with the weather threatening.

The indications are for fair weather in this district Sunday, with frosts tonight, followed by warmer weather Sunday afternoon.

The temperatures this morning over the Upper Columbia and Snake river basins range between 40 and 45 degrees.

PORT OF PORTLAND

Commission Will Borrow \$5,000 at 5 Per Cent.

At an adjourned meeting of the Port of Portland Commission, held late yesterday afternoon, it was decided to advertise for temporary loans in the sum of \$5,000 and upward, and the interest to be paid is not to exceed 5 per cent.

A communication from President Mears of the Chamber of Commerce, enclosing a letter from Wright & Co. of Liverpool, addressed to President Mohler of the O. R. & N. Co., was read. They request information about the delay of the terminal points in hauling it from mills at that place reported that the object of the visit was not attained. A letter from James E. Blackwell of Seattle, stating that the drawings of the drydock would be completed next week and suggesting that it would be best for him to come to Portland and then go East to ascertain the latest improvements in drydocks, was read. Mr. Blackwell was instructed to act according to his suggestion.

The new tender to the new dredge will be named the John McCracken, in honor of a prominent citizen and member of the commission.

It was decided to number the scows from 1 to 100, the smaller pontoons 100 to 150, and the larger pontoons 150 to 200. The commission expected an answer to their letter to the Federated Trades Council, requesting that the alleged defective timber in the 20-inch dredge be pointed out, but none was received. President Banfield reported that he met President Gurr of the council, who stated that no letter was received by him.

SOCIAL PORTLAND

A unique entertainment was held at All Thursday, bringing cargo to the Frank social. An interesting musical and literary program was rendered, and dainty refreshments were served. The title of the party was gained from the distribution among the guests of link silk stockings, each to be filled with pennies to double the amount of the size of the stocking worn by the recipient of the stocking. In this way a considerable sum was secured to be used for charity, and the guests secured great amusement during the filling of the hose.

The receipts in the six large packing cities—Chicago, Kansas City, Omaha, St. Louis, St. Joseph and Sioux City—according to the authority of the Chicago Drovers' Journal, are as follows: Cattle, last week, 14,000; a year ago, 127,100. Hogs, last week, 313,600; a year ago, 667,800. Sheep, last week, 115,200; a year ago, 157,000.

Toft, Hine & Co. report a plentiful supply of veal in the local market and a consequent weakening of quotations. Hogs still continue in light receipt. The receipt of beef has been more liberal the past week, but the supply is still short. The Portland Flouring Mills Company reports nothing doing in the grain market.
