

THE KING OF SPAIN

Crowned in Madrid With Great Pomp and Ceremony.

(Journal Special Service.)

MADRID, May 17.—His Majesty, Alfonso XIII, King of Spain, solemnly took the oath of the constitution in the Hall of Assembly of the Chamber of Deputies today, with the utmost ceremony and in accordance with all the religious forms and ancient rites.

Shortly after the break of day the ceremonies began with the opening of 21 cannon shots marking the opening of the day, and at the same hour the church bells throughout Madrid began ringing. At 10 o'clock the court dignitaries and distinguished persons who were to take part in the royal cortege began to assemble in the halls of the Royal Palace. The ladies wore court dress and the dignitaries were in full uniform. The Envoys Extraordinary, the Ambassadors, the Ministers Plenipotentiary, and the Charges d'Affaires, with their wives, assembled at the Palace at 11 o'clock and were invited by the master of ceremonies to repair to the Chamber of Deputies, and take the places reserved for them.

The firing of cannon announced to the expectant populace that the time had arrived for the departure of the royal procession for the scene of the day's ceremonies. Leaving behind the magnificent pile of granite and marble with its superb view of the Valley of Manzanares, the royal cortege moved slowly southward toward the capital. The entire route, which lay through the Calle de Alesia, the Puerto del Sol and other famous thoroughfares and public squares, was ablaze with color. The lanes and squares of the city for color and display had found vent in a wealth of decorations that was as bewildering as it was gorgeous and attractive. Entire house fronts were hidden beneath masses of red and yellow bunting and from every possible point fluttered flags and streamers bearing the royal coat of arms. The streets were marked by double rows of Venetian masts, from which floated banners of gorgeous hue.

The grand procession was headed by a detachment of cavalry forming the garison of Madrid. Following were the court dignitaries, the Mayors of the leading cities, members of the various local and provincial governments and representatives of the universities and other institutions of Spain. These were followed by delegations from the Senate and Chamber, the nobility, the church, etc.

The royal insignia, borne by high court dignitaries, included the Collar of the Order of the Golden Fleece, the sword, the standard and the seal of Castile, and the royal mantle of his Majesty. The Spanish crown, a circle of gold, richly decorated with jewels and precious stones, adorned with eight leaves and edged with four arches, surmounted the carriage in which rode the King and Queen-mother. The carriage itself was a dream of gorgeous color. The vehicle was a huge and cumbersome affair, according to latter-day notions, and was made for King Philip V. Its interior was richly decorated in purple and gold, while the outside was decorated with paintings by Rubens and richly inlaid with silver and pearl. It was drawn by eight magnificent horses with footmen and outriders clad in the livery of the

period of Charles V. In the front were squads of brilliantly uniformed soldiers, white at the side and a galaxy of Spanish generals. Two dozen carriages, scarcely less rich in their fittings and decorations, conveyed the Infantas and the great dignitaries of the royal palace. As the procession swept by, the troops in parade order presented arms and rendered all military honors to the royal party.

Conspicuous among these distinguished foreign visitors were Dr. J. L. M. Curry, the official representative of the United States; the Duke of Connaught, representing Great Britain; Prince Albert of Prussia, Grand Duke Alexis of Russia, Archduke Frederick of Austria, the Duke of Aosta, representing Italy; Crown Prince Gustavus of Sweden, Prince Christian of Denmark and Prince Albert of Belgium. The pope was represented by a delegation of eminent prelates headed by Cardinal Vannetti, former nuncio of Madrid.

The ceremony of taking the oath and the anointment occupied scarcely a quarter of an hour and was as follows: The Cardinal Archbishop of Toledo mounted the steps of the throne, placed himself in front of the King and invited his Majesty to make, before his faithful subjects and in a loud voice, his profession of faith, and presented him with the open book. The anointment and the administration of the oath followed, both ceremonies being conducted with great solemnity and impressiveness.

His Majesty received the benediction from the special envoy of the pope, who recited the prayer prescribed by the ritual. The young King arose and ordered that the royal mantle with the Collar of the Order of the Golden Fleece be presented to him. They were presented on cushions richly ornamented with gold. One of the assistants of his Majesty adjusted the royal mantle. In a similar manner his Majesty caused to be presented to him the scepter and sword, and having taken the scepter in one hand and the sword in the other he seated himself on the throne. In a few moments he arose and placed the sword and scepter on cushions beside him, where reposed also the crown of Spain. This terminated the actual ceremonies of the occasion.

The foreign representatives, the clergy, the grandees and all the persons present presented their felicitations upon the conclusion of the ceremonies of anointment and the administration of the oath. The procession then moved to the Church of St. Francisco El Grande in the same order and with the same ceremony that it had left the palace. All along the way there were enthusiastic shouts from the crowds that filled the streets and public squares. Alfonso XIII, now a King in fact as well as in name, graciously acknowledging the salutations.

The ceremonies at the church were simple but impressive. Here the clergy were the active participants, the chief actors of the day being little more than passive listeners. Upon entering the sacred edifice His Majesty proceeded down the long aisle lined by the grandees and their ladies and the foreign members and ambassadors. Arriving at the altar, the

young monarch handed the insignia of office to his attendants and knelt in prayer, while the archbishop read the litany. The service concluded with the Te Deum. Once outside the church and on the return journey to the Royal Palace, the king was greeted with the fanfare of trumpets, the booming of cannon, the ringing of bells and cheers from tens of thousands of throats.

At the great palace the utmost state was observed. The highest grandees of Spain, the august foreign princes and the leading members of their suites were in attendance with the officials of state, high officers of the army, eminent clergy and others. Only persons of the highest importance were present, the guests being entertained according to their rank.

THE TALK OF

GAY GOTHAM

Roland Molineux Trial Creating a Sensation.

(Journal Special Service.)

NEW YORK, May 17.—Each year brings additions to the list of famous people living in New York and 1902 is not an exception to the rule. With ex-Secretary of the Treasury Lyman Gage considered a New Yorker, there are now residing in the metropolis seven former members of the Cabinet, three of whom were Secretaries of the Treasury, namely, Fairchild, Carlisle and Gage; four men who have been Ministers to France—Bigelow, Morton, Reid and Porter; two ex-Governors of the State, two men who have been Lieutenant-Governors and 12 who have been Mayors either of New York or Brooklyn.

Preparations for the second trial of Roland B. Molineux are well under way, the same being under the direction of Assistant District Attorney Osborne. The trial probably will begin early next month and will, of course, receive all the sensation produced by the first trial two years ago. Patrick's trial caused talk enough, but it was a clean case, and was a scandal in the traditional "woman in the case" having been absent. But there is a broad river of filth running through the Molineux case which makes its retrial deplorable from the standpoint of public morals.

One of the most unique schemes for recruiting the ranks of any society ever heard of has been devised by the Equitable Life Assurance Society, which has agreed to establish a class of instruction in insurance for young men and women who are working their way through college and desire some employment to enable them to pay the expenses. The class will be under the instruction of experts in the business and during the one or two months' teaching the company pays the expenses of the members of the class. There will probably be more than 1000 in the class.

In the next National convention New York State will have 78 votes and the state will cast 39 votes in the electoral college for the Presidential candidate carrying the state. For several years the Empire State has had 72 votes in the conventions and 36 in the electoral college. The change is due to the recent Congressional reapportionment, which gave three additional Congressmen to the state. This gives New York 37 Representatives, with the two Senators. In each convention there are two delegates for each Representative and each Senator. There is one member in the electoral college for each Representative and Senator.

Recent events in Wall street have brought into prominence the "Curb Market." This is a market for securities not yet admitted to dealings in the Stock Exchange. These stocks and bonds are bought and sold in Broad street and here the young brokers engaged in this business trade for their customers and themselves in scores of new securities and some old. They constitute by no means an insignificant market and tens of thousands of shares are often traded during the day. For many years the market was in Williams street and it has come into so much unpleasant notoriety of late because it is so easy to manipulate the prices of stocks there and to create inflated values for suspicious or worthless securities.

BOYCOTT ON PLANING MILLS

Building Will Not Be Affected by the Strike.

The following notice was posted up by the strikers yesterday on all the boycotted planing mills and upon the wagons engaged in handling any of their material:

"These goods are unfair. Strike is now on. (Signed) Amalgamated Woodworkers' Union, No. 66.

The union men say this morning that they are encouraged by the situation, and think the general boycott which has been started will prove to be a winning card.

A number of carpenters have quit because they were asked to work with some of the material turned out at the boycotted mills.

Through labor union sources it is learned that teamsters and glaziers are also refusing to have anything to do with the material from the local mills. Through the action of their teamsters and other union employees, a number of the building supply houses in the city have sent to San Francisco and other points for material. David Keene sent for an extensive order to San Francisco.

"If none of the material from the local mills is used," said a prominent labor leader today, "it will not mean that building operations in the city will be retarded in the least. The general public is laboring under the false impression that the building industry will be paralyzed for any great length of time. This is an entirely wrong idea which has been formed. Any amount of material can be procured from the union mills in San Francisco just as cheaply as it can be had here, and the building industry will continue to flourish."

"There are more buildings going up now with a full complement of union help than was ever known here before. There were 30 building permits issued Saturday, and the unprecedented prosperity seen everywhere will not cease just because a few mills will not come to our terms."

ROAD SQUEBBLE NOT YET ENDED

The widening of the Macadam road matter is not out of the woods yet. It was "thought that with the agreement of the Riverview Cemetery Association, the Portland Driving Association and Multnomah County, arrived at yesterday, namely, that work should be commenced at a point 300 feet south of the cemetery gate, was good for all time. But it transpires this morning that Smyth & Howard, who have the contract for widening the road with Multnomah County, have something to say about it, and they were not given a chance to say that something at the triangular tract formulated yesterday. The contractors don't consent to 30 feet of their grading work being lopped off in any such manner. They claim that their contract with the county sets forth certain definite places of beginning and ending, and if this distance is curtailed they will be deprived of so much money.

Mr. Howard went to the courthouse this afternoon and consulted with County Surveyor Hulbert. He stated that he will go out and investigate the section of the road tomorrow and determine whether or not the 300 feet is worth making a fight over.

As Surveyor Hulbert puts it, the Macadam road proposition is like a piece of slippery, as fast as it gets off one finger it sticks on the next. First, the California Powder Works issued an injunction against the county, and when this was dissolved the River View Cemetery Association butted in and now after this difficulty was passed comes Smyth & Howard.
