OREGON BRIEFS.

SALEM.—Clarence Bishop, son of the Mayor of this city, has won a handsome athletic prize at the Textile School of Philadelphia.

OREGON CITY.—The strikers' committee here has issued a statement charging the mill operators with bad faith and reaffirms its determination to fight to a finish.

THE DALLES.—W. L. Woolsey, a shepherd from the Baker country, started a blaze in the Payette feed yards Saturday night. He was arrested.

SALEM.—J. Stitt Wilson, the Chicago Socialist orator, addressed two meetings in the City Hall on Sunday.

BAKER CITY.—Sheep shearing is on here in full swing. The wool yield is good, and high prices are expected. A \$400 nugget was found on Saturday in the Winterville placer mine near here.

TURNER.—The joint canvass of Marion County opens here tonight. Reduction of expenses is the main issue.

DIVORCE DENIED

In dismissing the bill for divorce, with counter claims, in the case of Mabel Carr vs. Robert Carr, Circuit Judge Sears stated this morning that it was the policy of the court to retain the marriage vows intact. It was a regrettable fact, it was observed, that reasons exist that made it impossible to grant a decree.

Mrs. Carr alleged that her husband had made false charges of unchastity, and, on the other hand, the husband averred that he was mistreated by his wife. Mr. Carr is reputed to be worth about \$20,000, and a part of Mrs. Carr's demands were for

alimony. A large family of children is the issue of the marriage.
Judge Sears said that, after weighing all the facts of the case, he had come to the conclusion that both parties were at fault, but that, in justice all around, it was deemed best not to grant a decree of divorce.

FOR MUNICIPAL JUDGE.

George J. Cameron, the present Judge of the Municipal Court, is an independent candidate for re-election. It is nearly two years since Mr. Cameron assumed the duties of his present public office, and he is one of the occupants of the bench against whom not a derogatory word has



yet been spoken. All his transactions have been open and above board. He has been noted for his fairness, and has been uniformly sustained by the higher courts. He is one of the sober, thoughtful judicial officers of the city, and his zeal in the discharge of the duties of the place ought, it seems, have weight enough to continue him where he is.

WILL NOW TRY FRANKIE THOMAS

The diamond robbery case is not closed yet. District Attorney Manning stated this morning that he would now try Frankie Thomas, alias Savage, on the charge of receiving stolen property.

Frankie Thomas is the consort of Charles Savage. She was originally arrested on an information charging her with the larceny of the diamonds, but that phase of the case was dismissed at the conclusion of the first trial of Savage, and she was rearrested on the latter charge.

It is believed by the state's attorneys that they can secure a conviction.

NEARLY KILLED

Boy Stood on Car Track—Both Legs Broken.

Clyde Middleton, residing on West avenue, Mount Tabor, is lucky that he is alive today. Middleton was standing on the track of the Mount Tabor division of the City & Suburban Company's line at West avenue, when one of the large heavy cars came along and struck him a terrific blow, throwing him in the air and breaking bones in both legs.

He was at once removed to Graham's drug store on West avenue, and Dr. Bolkins of Mount Tabor instantly called. The injured boy was afterwards removed to his home, and his condition at present is reported as being very serious.

The fault of the unfortunate accident undoubtedly lies with the boy, as he saw the car coming and stopped on the track in front of it, when but a few feet distant it being too late for the motorman to check the speed in time to save him.

He is the son of Daniel Middleton, and resides at Mount Tabor.

NEW HEADLIGHT.

Wonderful Electrical Appliance On the Milwaukee.

The Chicago, Milwaukee & St. Paul Railway Company has recently adopted a safety appliance in the way of a headlight for its locomotives that is a wonder. It illuminates the track for a mile ahead in advance of the train, and also casts a vertical ray 700 feet in height. This can be seen in the darkness from one to 10 miles. It is calculated to prevent collisions at curves in the road. The horizontal headlight warns engineers

approaching, only when the line is straight. If there be a curve and intervening hills, it can give no warning of the approach of the train whose eye it is. The vertical light throws its sign upon the sky long before even the rumble of the train can be heard.
With ordinary watchfulness on the part of engine crews, the new headlight reduces the liability of head-on collisions to a minimum. The National Magazine for April says of the new appliance:
"The apparatus consists of a powerful electric arc headlight, a dynamo and steam motor, all of which occupy the space on the locomotive usually devoted to the headlight. The dynamo which generates the current for the search light occupies a space less than 15 inches wide directly behind the headlight, and is operated by a motor driven by steam impact on a turbine wheel. The current is 6,000 candle power."
It is a matter in which the railroad, the Federal law-makers and the Interstate Commerce Commission all co-operate heartily in any device that tends to lessen fatalities. The adoption of safety appliances ordered by Federal enactment, has been general. Many of the general managers have conducted independent experiments with a view to preventing accidents. The wonderful headlight used by the Milwaukee is the result of this line of action.
