

UMATILLA COUNTY Gave Chamberlain Six Big Meetings.

(Journal Special Service.) PENDLETON, May 24.—Such immense crowds turned out last night to hear George E. Chamberlain that they filled the Courthouse, seating 700, and then in an overflow meeting filled the Frazier Opera House, which holds 750.

Mr. Chamberlain and W. A. Wann spoke in Umatilla County at six meetings during the day. They opened at Milton at 11 o'clock, drove to the station one mile away and addressed another big crowd; took the train for Weston, and spoke again, the train being held an hour for them, after which they went to Astoria, where another great crowd cheered them on their way and applauded their speeches. They then boarded the train for Pendleton, and at the station were met by 300 people, who escorted them to their hotel.

The regular rally was planned for the Courthouse, but that room was jammed and crowded until hundreds were turned away. A. D. Stillman, county chairman, who had taken them on their tour, quickly searched out the manager of the Frazier Opera House, and, taking one of the two bands with him, formed a line of march to the theater, which was filled in a few moments, so many coming that it was almost necessary to organize another overflow meeting.

At every place they appeared there were throngs of people, who listened attentively to the addresses. Enthusiasm was rampant, and there are few skeptics in Umatilla County today who do not concede that Mr. Chamberlain will carry the county with a flattering margin.

OREGON CITY.

(Journal Special Service.) OREGON CITY, May 24.—A large sawmill, with a capacity of from 2,500 to 3,000 feet, will be erected on the West Side above the falls at once. The principal proponent of the enterprise is Carl A. Patisall, recently from Prairie du Chien, Wis., where he was extensively engaged in lumbering. He recently formed a partnership with C. Moehnk, who owns a small sawmill on the West Side. The contract for the new machinery was made with F. J. Miller of the Albany Iron Works yesterday afternoon, and an order will be added to the equipment. Much of the finished lumber used in building here is brought from Portland, and the opportunities for shipping to outside markets are good as elsewhere.

All the old teachers who filed applications were re-elected. One new teacher was added to the total former number, as another room will be required for next year.

CHEAPER FARE FOR SCHOOL CHILDREN.

The City & Suburban Railway Company has decided to sell to actually enrolled pupils of the public schools transportation books allowing 33 rides for \$1 these tickets to be good only on school days, between the hours of 7:30 a. m. and 5 p. m., with such other limitations as may seem necessary to confine their use to the purpose intended.

This rate will be put into effect as soon as the necessary tickets have been prepared, but owing to the fact that the schools will close in about three weeks, it is quite probable that it is now too late for this term.

Seattle and Tacoma give a 75-cent fare to all school children, but the conditions of use are very strictly limited. In Spokane they are sold to children under 14 years of age, and in Denver to children under 12 years of age. In the cities of Omaha, Kansas City and Terre Haute (Ind.), all cities of some near the size of Portland, no concession whatever is given.

MEETING IN THE FIFTH WARD.

Citizens Had a Rousing Meeting Last Night at 16th and Jefferson.

Members of the West End Citizens' Club asserted their loyalty to the non-partisan Citizens' ticket in a most unmistakable manner last night. They with many other residents of the Fifth ward assembled in an improvised hall at Sixteenth and Jefferson streets and for two hours paid close attention to the advocates of the Citizens' movement and the arguments presented in behalf of the Citizens' ticket. Owen Jones, President of the club, presided at the meeting and addresses were made by a number of Citizens candidates while Frank D. Hennessy entertained the large crowd with his singing.

Robert D. Inman, Citizen candidate for Mayor, was the principal speaker, giving to those present one of his practical and sensible talks on the purposes of the Citizens' movement and the assurance it gave of good government to both county and city in the administration of the people's official business. He concluded that the principles involved were higher than any demand that could be made on account of party affiliation and the great number should meet with the hearty approval of all as it was a matter of vital importance to every citizen.

"The Citizens' ticket," he said, "had been presented to the people with the one object of securing good government; its candidates came direct from the people and those who were interested in giving the people the government these candidates pledged themselves to give, could do no better than support the Citizens' ticket from top to bottom."

Regarding the laboring men, Mr. Inman remarked that if the employer of labor make it a duty to keep closer in touch with the men in their employ, there would be no occasion for the existence of the present condition of affairs. He said he would listen to their grievances, always help to straighten out any entanglements arising and he had always met with success in so doing. Employers, he maintained, should always show an interest in those who worked for them. In this connection Mr. Inman paid a neat compliment to John Driscoll, the Citizens' candidate for Sheriff. John Driscoll, he said, was a man who had rubbed shoulders with working men and was an honest, square man, one that could always be trusted and who could be voted for with a good conscience. In narrating an interview he had had with a capitalist during the day, Mr. Inman said he was asked why were working men elected to the Legislature last year as they had not really enough to fill such positions. Mr. Inman was concerned, it was not such a matter of brains as it was to find an honest man, but it would be found that working men were probably as well supplied with brains as others. The working men were the bone and sinew of the country and, in fact, are really the men who run it. In closing he appealed to all present to vote as they thought would be right and for the best interests of the people, and not to let anyone influence them against their convictions.

Woman's Club Meets.

The meeting of the Woman's Club yesterday was particularly full of interest and was attended by an audience that taxed the seating capacity of the hall. At the business meeting the subject of kindergarten was principally discussed, the chief question being the advisability of having them become a part of the public schools of Portland as they are in many other cities. This question will be decided at the coming June election and support of the Woman's Club in sustaining the six schools now established and if possible to build more institutions of the kind. The subject was presented in short addresses by Mrs. Helen Ladd Corbett, Miss Pritchard, President of the association, and Professor Rigler, City Superintendent of Schools. Mrs. Marquam read a most entertaining account of her visit to the biennial Federation of Clubs at Los Angeles, which told of the matters of interest to all that were not generally told.

The program of the day was under the direction of the New England Club, made up of women who have studied at the New England Conservatory of Music. It was undoubtedly the best combination of music one could hear. The numbers were given in a way that was purely artistic and of great merit. Those contributing the program were Mesdames Piper, Goddard, Hamilton, McGinn, Shillock, Linn, Shultz, Berry, Hall and Miss Watt.

A wand drill by a mixed class of 60 boys and girls was followed by a marching competition between the girls and the boys, in which the girls were victorious. The audience decided the contest. The senior class gave an exhibition on parallel bars that was excellent. Apparatus work was next done by both the girls and the boys' classes. Especially good was the minuet danced by the ladies' class, which was almost perfect in training. A number of girls dressed in white gave a Maypole dance, which was applauded heartily, and while they were still on the floor a Highland fling was danced by Miss Nance Black and Miss Rose Forbes.

SUICIDE BY CARBOLIC ACID.

Mrs. R. W. Hoopengamer Takes Her Life This Morning.

Mrs. Birdie Hoopengamer, alias Hall, a dance-house woman, committed suicide this morning.

The woman has a husband on the East Side who is a blacksmith, and who has been trying to become reconciled to her for some time, but without avail. Mrs. Hoopengamer started out last night on a carousal with several convivial friends, and wound up in the Home Ranch saloon this morning. At 10:30 she left them in company with G. M. Dunn, one of the proprietors, and went to her room, No. 4 Saratoga house, Third and Couch streets. After a little conversation between the two, the woman wrote a note and then Dunn noticed her open a bottle and commence to swallow its contents.

Dunn ran to the woman and grabbed the bottle, but not before she had swallowed over an ounce of the drug. A physician was summoned, but he could do nothing for the unfortunate, as she was beyond all human aid, so the Coroner was notified.

The note Mrs. Hoopengamer scribbled follows: "Dear Mother—I will rite you a few lines these are the last lines you will ever receive from your little daughter so farewell to you." Dunn says that the woman was very drunk at the time she took the poison and, in his opinion, she took the fatal step through remorse over the treatment she had accorded her husband.

An inquest will be held at 4:30 o'clock this afternoon.
