

CITIZENS OF THE SECOND AND THIRD WARDS HONOR INMAN

The open air meeting under the auspices of the voters of the First, Second and Third wards, held last night at Park and Gilliam streets, plainly indicated the trend of public thought. It was in effect a magnificent demonstration of approval of the candidacy of H. D. Inman, the Citizens' nominee for Mayor of Portland.

Men representing all walks in life were present, but the element that largely predominated was those who after a day of hard work had thrown down their tools and joined in the demonstration that emphatically impressed upon the minds of thousands that Honest Bob Inman would be the next Mayor of Portland.

Fully 2000 people stood for two hours listening to the plain argument in behalf of good government and the Citizens' ticket. Workingmen from the mills located in the northern part of the city marched southward with torches and banners to the line of Morrison street headed by the Southern Pacific band to meet their fellow workmen with torches and banners from the East Side mills, headed by the Third regiment band and join in one long procession to the place of meeting. A steamer engine mounted on a wagon drawn by four horses shrieked defiance to Jack Matthews and his machine, an immense circular saw in full motion, the emblem of honor that use Inman men rallied around and a big search light threw its glare of flame up and down the streets and upon the score of banners that all might read the joyful tidings that the idol of the working men, H. D. Inman, who had risen from their ranks, the Citizens' candidate for Mayor, had the unanimous support of organized labor and would be the next chief magistrate of Portland.

THE MEETING WAS ENTHUSIASTIC. The meeting was presided over by J. B. Ryan as chairman, and as each of the speakers spoke in rapid succession in behalf of the Citizens' movement the great enthusiasm was manifested by the immense crowd gathered. Dr. Harry Lane, Citizens candidate for State Senator, was the first to be introduced and made an able argument for the Citizens' ticket, saying the time had come when the people of Multnomah County should attend to their own affairs without the assistance of a few political bosses no matter what party they happened to represent. "Nothing is so well done for the people," he said, "than that which the people do for themselves. The retention of the Philippine Islands cut no figure in the local campaign of Multnomah County, but to allow any possible fear on the part of some timid people, he would, on behalf of the candidates on the Citizens' ticket, guarantee that in the event of their election the Philippine Islands would be retained. We will also uphold President Roosevelt and when he comes to Oregon give him a hearty reception. We will welcome him as a good citizen and try to induce him not only to come

here himself but to bring his family with him and stay among us.

"The one object of the Citizens' movement is to secure the election of a ticket that will be in the best interest of all the people and in that effort we believe we have the right to expect your support. It is for the common good and best welfare of the people of Multnomah county, and assures you of an honest administration of the people's affairs.

"I wish to call attention to one report that has been circulated in this portion of the city concerning me. It is said I am in favor of W. D. Fenton for United States Senator. That statement has been made by Larry Sullivan. All I want to say is that I want to do my own thing and Sullivan need not lie for me. If he continues to make such a statement I will have to call it to the attention of Mysterious Billy Smith for proper correction. (Great Applause).

A. C. SPENCER'S ADDRESS.

Spencer said: "If there had been any question as to where the heart beats of the community were as to the result of the coming election it must have faded away before such a manifestation of approval by the people of the Citizens' movement was witnessed tonight. He made no claim as a politician or an orator, but gave the following reasons why he would support the Citizens' ticket: "First—Because he objected to the introduction of national issues into the settlement of purely local matters. 'We are here,' he said, 'to settle our own affairs, and no one has the right to say that in supporting the city ticket we are antagonizing the administration.' "Second—I intend to support the Citizens' ticket because of the manner in which nominations were made.
