FURNISH RETICENT When Asked How He Stood on the Labor Question.

(Journal Special Service.) BAKER CITY, Or., May 29.—F. E. Holman, president of the Greenhorn Mountain No. 22, National Federation of Labor, an engineer engaged in the mines in the Greenhorn District, who has been on a visit to his home in Salem, has just returned, and states that while there he had the pleasure of witnessing both the Chamberlain and Furnish rallies, which he attended for the purpose of informing himself on the political situation of the state. Mr. Holman says: "After the Furnish meeting, I went direct to Candidate Furnish and without prevarication put a straight question to him. I asked him how he stood on the labor question. Mr. Furnish replied to my question very briefly. He said that he was in hearty accord with the plank in the Republican platform relative to labor and that he believed in organized labor and believed that labor had rights to organize, etc. This was all the statement that I could get out of him, and Mr. Furnish seemed in a hurry to get away with an apparent effort to evade the main question, turning me off abruptly."

in order to attend to other business. CHAMBERLAIN WAS CORDIAL. "I met Mr. Chamberlain on Saturday afternoon. I put to him the same question in regard to labor and his attitude on that proposition, after being introduced to him by Frank Durbin, Sheriff of Marion County. Mr. Chamberlain was very cordial and said that he was glad to meet me, but that he was on his way to the depot to catch the train and did not have much time to spare, but invited me to walk down to the train with him and he would discuss the matter. He said that he was particularly pleased that I had approached him on the subject in the direct manner in which I did, and that he would reply in like honesty. He said that he was heartily in sympathy with the labor movement and freely endorsed the plank in the Democratic platform, and that if elected he knew it would be by the labor vote of the state, and that he would promise, if he was elected, to support and encourage with all the power and dignity of the office of Governor, the interests of labor. IN HONOR OF MCKINLEY

Heroic Bronze Statue Unveiled to His Memory.

(Journal Special Service.) MUSKOGON, Mich., May 30.—A heroic bronze statue of President McKinley, one of the first monuments erected to the martyred President in the country, was unveiled here today with imposing ceremonies. It was a gala day for Muskegon. Visitors were here from all of the neighboring counties and the day was observed by everyone as a holiday. The unveiling ceremonies were preceded by a big parade, the various divisions of which included, besides scores of Grand Army veterans, delegations of Knights Templar, Elks and other orders from Travers City, Grand Rapids, Manistee, Big Rapids, Lansing and other cities of the state.

The statue is a gift to the city from Charles H. Neuhaus, and represents McKinley in the pose he assumed in the delivery of the last speech at Buffalo, N. Y. It is seven feet high and mounted on a pedestal which rests on a granite base 30 feet square. The base bears the following extract from the late President's public utterances: "Our future conquests must lie in the victories of peace, in concord, not in strife." The statue is a gift to the city from Charles H. Neuhaus, and represents McKinley in the pose he assumed in the delivery of the last speech at Buffalo, N. Y. It is seven feet high and mounted on a pedestal which rests on a granite base 30 feet square.
