

THE NEXT GOVERNOR

Addressed a Hummer of a Meeting on the East Side Last Night.

The violent rainfall last evening and the threatening weather following had no deterring influence on the residents of the Ninth ward and vicinity, who turned out en masse to listen to George E. Chamberlain, Oregon's next Governor, discuss the political issues of the present wide-spread political campaign.

Burkhardt Hall was crowded with enthusiastic supporters of Chamberlain's candidacy for Governor, and the overthrow of Ring rule in Multnomah County. Dr. John Welch presided at the meeting, and many prominent Democrats occupied places on the stage, the central figure of whom was Oregon's favored son, George E. Chamberlain, who, nominated by a Democratic state convention, has become in fact the people's candidate for Governor.

When Mr. Chamberlain was introduced by Chairman Welch as the next Governor of Oregon he was greeted with tumultuous cheering and applause that continued for several minutes, and when it had subsided sufficiently for him to remark that "this frosty reception almost overcomes me," the applause was vigorously renewed. In his opening remarks Mr. Chamberlain referred briefly to his trip throughout the state, the great crowds of people gathering to hear him, and the enthusiasm shown everywhere in his behalf. He said:

"If my opponents are not satisfied with my style of campaigning, they have themselves to blame. They should have set the pace. They put forth the claim that I do not talk on partisan lines. Why should I? The people have honored me more than once and such honors came to me through the help of my Republican friends. I couldn't abuse them if I desired to. The fact is, there is no partisan politics to discuss this year. Compare the two platforms and you will find them very similar. My opponents have adopted the Democratic platform, put a Democrat on it as their candidate for Governor, who now poses before the people in his trip over the state as a man of action and saying, 'Look at me. I AM IT.'"

"At a meeting in Gones Hall last night I referred to the extravagance displayed in the fiscal affairs of our state. The Oregonian had a reporter present at that meeting, but its report of what I said was unfair. Why any paper should be guilty of such willful misrepresentation is beyond my comprehension. It ought to be at least fair in its reports. When I refer to the extravagances that have grown up in the administration of our state affairs, I want you to dismiss from your minds that I am criticizing the president or any other administration." Mr. Chamberlain then explained at some length, as reported in The Evening Journal yesterday, the nature of the extravagances that had become a part of our state administration and then said:

"This is not a question of reasonableness or unreasonableness, but of what the constitution of our state means what it says when it puts a limitation on the emoluments that the state officials shall receive. I promise you that, if I am elected, I will put the responsibility upon the courts to declare whether or not the constitution means what it says. The Oregonian says there is nothing in this fair salary business, that nothing will ever come of it. I can only say that both parties are pledged to it, and if I am elected, I will make an honest effort to

carry out any pledge that I have made to the people.

"When Oregon was admitted as one of the states of the Union it was presented with a large land grant, which if properly husbanded would have been sufficient to have educated every child in the state without the necessity of levying an additional district tax for support of our schools. Most of this land has been frittered away, sold at a minimum price of \$1.25 to \$1.50 per acre, when it should have been disposed of on the plan of selling it to the man who would pay the highest price for it.

"INSURES AN HONEST ELECTION.

"The Oregonian says I ought to resign my present position and that I am now making a campaign at the expense of the state. I don't propose to resign. I intend to remain in business at the old stand for awhile. Before the primaries that paper held me up as a sort of bogeyman, and when the third election was over, it declared it was the honestest in the history of Portland. I have no money to use in this election, but if I had millions, not one dollar would be used to defame the election next week by following the methods of Mark Hanna. I don't say any one will use money, but if any attempt is made to use money for my election or the election of any one else, I will prosecute them.

"POOR MAN—GENIAL FELLOW.

"The argument is raised that I am a poor man and my opponent is a rich man, therefore should be elected. Has it come to that? Must a man in order to be elected to office be a man of wealth? I think not, and if all the poor men an Oregon vote for me I will have an overwhelming majority. Again, fault is found because I am a genial, companionable man. I would rather that one should stand over my grave and say that George Chamberlain was a genial man, a man who would not refuse in private to listen to the appeal of the widow or orphan, and one who would turn an attentive ear to the prayer of the condemned or unfortunate, rather than to have one say of me after I had passed away that I was a man of wealth, that I had endowed a university, but refused to listen to the appeals of the bereaved and unfortunate. I am not ashamed of the charge of being a genial, companionable man. I am glad of it. Early in life I learned to treat all men alike. The millionaire can come to my office and be treated with the same courtesy as the humblest working man. No more, no less. It is not what the man has on the outside, but what is in the inside, I believe in geniality, in companionship."

Mr. Chamberlain referred to the proposed amendment to the constitution giving the initiative and referendum to the people. He said such measure had originated in the minds of the humble citizens and urged every one to vote for its adoption. He claimed such provision gave the people a voice in legislation of the state and the power to reject laws passed that were inimical to the best interests of the people.

W. A. Wann, candidate for superintendent of public instruction, and Henry Blackman, candidate for State Treasurer, made short addresses, and during the evening Frank Hennessy and Mrs. John P. Watts entertained the audience with several songs that were enthusiastically received.

On Saturday night Mr. Chamberlain closes the campaign with an address to the people at the Tabernacle, corner of Morrison and 12th streets.

C. E. S. WOOD NAILS A LIE

Tells How He Was Misquoted in an Interview.

C. E. S. Wood, who returned to Portland today, writes to the Oregonian to refute false statements made in that paper in a telegram purporting to give his views on the present election. Mr. Wood writes:

Editor Oregonian—Your Ashland interview with me, published the 28th, is substantially false. I have not hit my party. I believe in it wholly. I am in entire sympathy with all Democrats and value their nomination of me unalloyed as much as I would election. There is no warrant for your headlines in your own publication. Furnish was never mentioned, and I do not know today what the defamatory campaign against him is. Scuttle or anti-imperialism was never mentioned. My going on the stump, or what I would do was never mentioned. I said Republicans were claiming Williams, Democrats Inman, and I had returned to Portland recently to have an opinion myself. I did say I thought election times should be used to actively propagate the party doctrines. The purpose of your headlines and falsification of me is evidently a reckless and malicious effort to serve Republican campaign ends, and I shall hold all concerned responsible, and demand that this explanation be as fully and conspicuously published as the original statement. The telegram to which he referred as printed in the Oregonian was:

ASHLAND, Or., May 27.—C. E. S. Wood, whom the Democrats of Oregon have named on their state ticket as a candidate for United States Senator, was here this morning en route to San Francisco, where he goes on legal business. He says he only returned a few days since from a several months' visit East, and has not been back long enough to have a clear opinion of the political situation, but that the preponderance of expressed opinion of others inclines him to believe that George H. Williams will be elected Mayor of Portland. He expressed no sympathy with the personal and defamatory campaign the Democrats are waging against Mr. Furnish. He believes a party should, when it has enunciated its principles, go before the people and plead with them, and not run away from them. Mr. Wood will not be heard on the stump for the party whose candidate he is for United States Senator, for he is a warm advocate of the "scuttle" policy in the Philippines, and would take a firm stand on that question should he address the people.

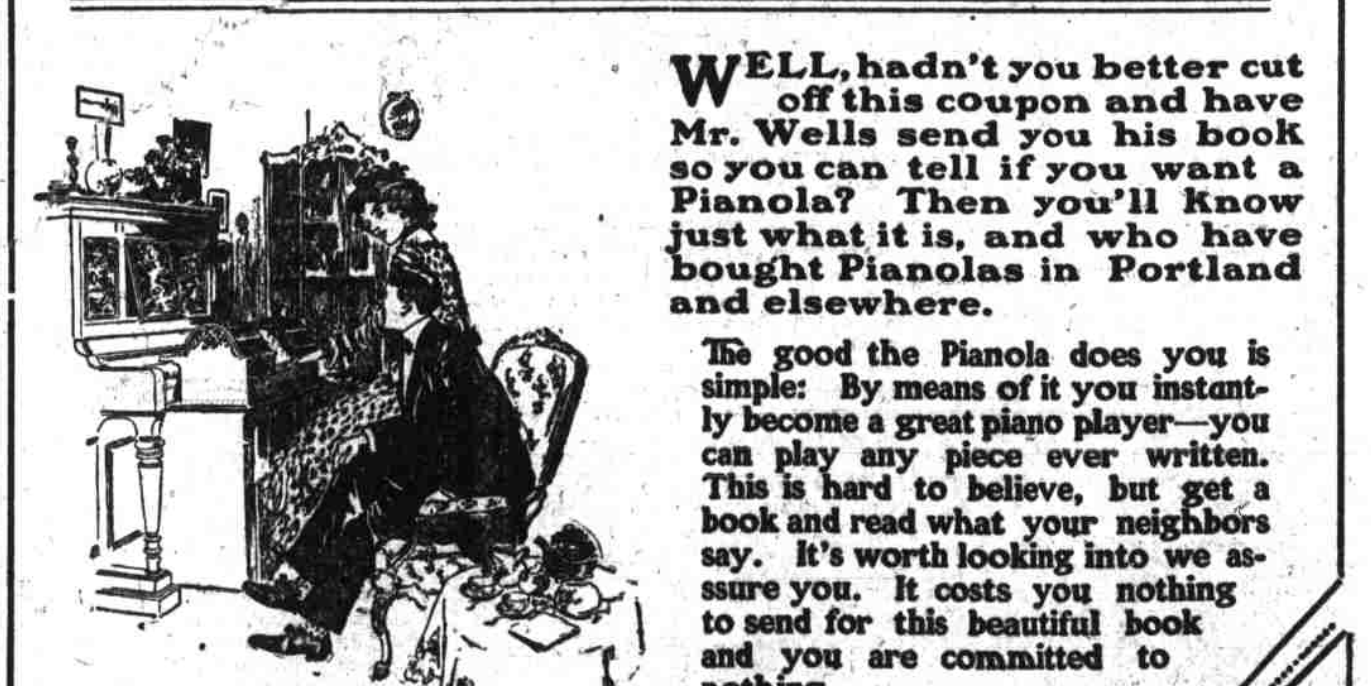
