

FIERCE FLAMES

Deal Out Death and Destruction in Saratoga.

(Scripps-McRee News Association.)
SARATOGA, N. Y., June 9.—One is killed, several are injured and a number are reported missing as a result of a fire here early today. Property valued at \$200,000 was destroyed. Mrs. Elizabeth Mable was burned to death in her apartments. The fire started in the Arcade building and spread to the Shackelford building and the Saratoga Theater, all three being destroyed. Among the losers are the Daily Saratogian, the Western Union, the Saratoga & Boston Telegraph Company, the Municipal Telegraph & Stock Company, and the Saratoga County Treasurer's office. The missing, seven in number, were occupants of the Arcade. LATER—All the missing are now accounted for except David Howland and wife, Sarah Owen and Miss Harrington. Fire Chief Chadwick was seriously injured. The Funds and Citizens' National bank buildings were also destroyed.

FOR CHARITY

The Hunt Club Event Drew Big Crowd.

It was a glowing picture presented at the meeting of the Portland Hunt Club on Saturday afternoon at the Irvington track, where the annual field day meet took place. Sleek, smoothly-groomed chargers, glistening equipages, handsome men and handsome women were some of the adjuncts. Added to this was the ideal day. Taken altogether, it is the unanimous opinion that the event was one of the most successful of its kind that has yet taken place.

The first event was a parade of 20 mounted members of the club, under the leadership of James Nicol, mounted on Gypsy Queen, and who is ringmaster of the Portland Riding Academy. It was a graceful sight. Against the background of blue sky the women riders, in their dark skirts, white waists, dark Derby hats and badges of red, stood in bold relief.

There were seven entries in the one-mile running race. E. M. O'Brien, of Morengo, won out in 1:24; V. S. Howard second, C. H. Lewis third.

The third event was the tandem trot, one mile, in which five were entered. A. M. Cronin, on Daning Girl, passed under the wire at 2:08, winning the F. W. Leadbetter cup; E. T. Chase was second, R. H. Jenkins third.

In the half-mile junior race, Leslie Oliver was in the lead at the finish; time, 6:55. Hamilton Corbett, on Winnie, came in second. The winner was awarded the J. Wesley Ladd cup.

There was quite a flutter when the trap show came on. The contestants lined up before the grand stand in this order: George I. owned and driven by A. T. W. Kerr; Dotts; owned and driven by Anita Burns; Bobby Burns Jr., owned and driven by L. I. Thompson.

Dotts captured the decision for first, George I second.

In the single trap contest, Mrs. F. Downing gained first prize, Mrs. Peckheim second and T. T. Strain third.

In the double trap event, E. L. Thompson came in for first prize, H. C. Bredon second, B. F. Hayden third. In one of the traps was Mayor-elect Williams, Mayor Rowe, J. C. McCormick and H. C. Campbell.

In the pony race, a quarter-mile dash, Leslie Oliver won on True Blue in 1:24.4; Jack Reed second, H. Jamison third. The prizes for the winners were: First, a saddle, presented by John Clark & Son; second, a bridle, from W. H. McMonnies; third a whip, from George Lawrence Company.

In the mile trot, James Nicol came in first, Mrs. F. G. Buffum second, A. M. Cronin third. The prizes for this event were the J. W. Cramer cup and a pair of leggings, from H. S. Ervin & Co.

Eva N., Bob Proudly and Sea Wave were the winners, in the order named, in the stable boys' race. Eva N. made the distance, five-eighths of a mile, in 1:25. The grand finale was the hurdle race, for two miles, over eight hurdles, for the F. O. Downing cup. For this were entered:

There never has been an event of this kind in Portland which proved of more interest, and there was great excitement. Strenuous Ted came in first (time 4:38.4-5), Howard second, Lasarus third.

The Fruit and Flower Mission realized \$115 from sales of refreshments in the grand stand.

The starter of the races was M. D. Wisdom and the judges were A. H. Tanner, W. W. Catton and W. L. Archambeau. Samuel Waller, veteran of the Second Oregon and the Thirty-ninth Regiment, United States Infantry, acted as bugler and time-keeper.
