A. A. BOGART WAS KILLED

At Sheridan While in the Railroad Yards.

(Journal Special Service.) SHERIDAN, Or., June 18.—A. A. Bogart, baggage and express messenger for the Southern Pacific Sheridan local, was killed in the yard here about 3:35 p. m. It is not known whether he was attacked with vertigo or was reaching for something when struck by the steps of the combination car which was being kicked on the turn-table track. Deceased was about 29 years old, and married in November last to a daughter of D. W. Ralston, of this place. Besides his wife, he leaves his aged mother, a sister and three or more brothers who reside in Portland.

WORKMEN AT SALEM

Supreme Lodge and Superior Lodge Visit Capital City.

SALEM, June 17.—The Supreme Lodge, A. O. U. W. and the Superior Lodge Degree of Honor enjoyed the generous hospitality of the people of Salem yesterday, and to such an extent as to surprise the visitors, as they probably have not been surprised before. Under the special excursion train arrived in this city at 10:30 a. m. a band and a large crowd of workmen and ladies of the degree of honor met the visitors and escorted them to Marion Square, where tables were spread, grouting under the weight of a sumptuous repast prepared by the local workmen for the guests from 40 states. The substantial were flanked by luscious strawberries, rich cream, and other delicacies, and all were provided for while the rich floral decorations were presented to the strangers and later taken away by them.

Following the feasting Frank Davey, mounting a platform, introduced Gov. T. T. Geer, who, in his inimitable manner, welcomed the visitors to the state. Supreme Master Workman Harwick, of Buffalo, responded, and he was followed by Supreme Foreman Web, McNall, of Gaylord, Kan., and Mrs. Ella H. Maitor, of Minnesota, Superior Chief of the Degree of Honor. Later Hon. Samuel Booth, of California, rendered an improvised song, extolling the beauties of Oregon, and Hon. W. M. Sackett, of Pennsylvania, Supreme Recorder since 1879, completed the short program by delivering a brief address on the work of the order.

At 1 p. m., the visitors, loaded with the fairest roses ever seen by them, were escorted to the train, and, after the goodbyes had been said, were whirled away to Albany, where the program was repeated. FORCE CUT DOWN

Supt. Ormsby, of Forest Reserve, Measures Timber.

(Journal Special Service.) SALEM, June 18.—Superintendent S. B. Ormsby, of the Cascade Forest Reserve, recently went to Dufur, under orders from the Interior Department, to measure up a quantity of timber, purchased from the government, by the Dufur Lumber Company, and he has just returned from that trip. He reports that his force of supervisors has been cut down by the department, the reserve being cut into two divisions instead of three as formerly, and W. H. H. Dufur, of Dufur, and S. C. Burtram, of Roseburg, are the supervisors of the northern and southern divisions, respectively, serving at a salary of \$1,000 per annum. A number of the forest rangers for this year have been appointed, and some of these have already gone into the woods to begin the season's work. Others will be named soon, and in the course of a few weeks the entire force of 60 rangers will be at work. The rangers serve during the summer months only, and are paid \$60 per month, the men furnishing their own outfit, horses, supplies and provisions. The rangers for this year, already appointed, are:

(Journal Special Service.) THE DALLES, June 18.—Monday was election day at The Dalles. There was but one ticket in the field, the Citizens, comprising both Democrats and Republicans. All the present city officials were re-elected with the exception of Mayor, which are as follows: Treasurer, Jesse C. Grandall; Councilmen Second Ward, James Kelly, Charles W. Dietzel; Third Ward, Dr. Shackelford; First Ward, Joseph Worsley, Mayor; Frank S. Gunning, Two water commissioners were also elected, the present incumbents being returned, Ted. Seufert and Hans Hansen. The only fight that was made was for school directors, there being five names in the field and but three vacancies. E. S. Hunting, R. H. Weber and Henry J. Maier were elected. William, the 11-year-old son of Mr. and Mrs. William Birgefelt, died in this city Sunday of inflammatory rheumatism. The funeral occurred from the family residence this afternoon, Rev. Wm. Brenner officiating. The interment was made in the Odd Fellows Cemetery. The club women of this city have organized a Sorosis and held their first meeting last night. The year's work has been laid out, and includes the study of authors, the world's history, social days and the reading of the history of Oregon. Jesse Eaton, who died at the home of his son, Edward Eaton, at University Park, Portland, last Saturday, was an Oregon pioneer of 1846. He was born in 1826 in the state of Kentucky, and in the spring of '46 started across the plains by ox team, being six months on the way. He first took up his abode in Polk County, where he remained until 1883, when he removed to The Dalles, and the following year he took up a claim near Wasco. He had made his home in Portland for the past year with his son, Edward, who resides at Univer-

sity Park. The deceased was sick but a short time, being afflicted with erysipelas. Mr. Eaton was married in 1859 at Grand Ronde, Polk County, to Miss Mary Burden, whom, with 19 children, survives him. The children are Nathan, Jesse and George, of Wasco; Edward, of Portland; Maggie Eaton, Mrs. W. Wilerton and Mrs. C. W. Bargee, The Dalles, and Emma Giesel, Portland; Mrs. Laura Rayburn, Everett, Wash. He was widely known by all farmers and stockmen throughout Eastern Oregon. Mrs. Harriet Lucy La Dow, a resident of this state since 1881, died in this city Sunday, after a lingering illness of several years, the result of a paralytic stroke. The deceased was born in New York, March 30, 1828, and was married to William C. La Dow in that state. They came to The Dalles 21 years ago, where they have since resided. Three children survive her. Frank La Dow, of Portland; Willis C. La Dow, of Los Angeles, and George La Dow, of this city. The funeral will be conducted from the family residence this afternoon, Rev. Walter Skerworth, of the Methodist Episcopal Church, officiating.

NEW OFFICERS

In Oregon City Have a Few Applicants for Jobs.

OREGON CITY, June 18.—The newly-elected county officers are preparing to enter on the discharge of their duties July 1, and several appointments of deputies have already been made. County Recorder-elect, Henry E. Stevens, who was elected by nearly 1500 plurality, has appointed Chauncey Ramsay as his deputy. J. R. Shaver, Sheriff-elect, says that it is probable that he will appoint E. C. Hackett as his chief deputy. No appointments have yet been made by F. A. Sleight, County Clerk-elect, but there are two prominent candidates for the chief deputyship, J. W. McNulty, Justice of the Peace of the Oregon City district, and S. J. Buford, chief engineer of the fire department. The former is circulating a petition asking for his appointment, which is being numerously signed. The platforms of both political parties demand that the County Judge be restored to his old place as Judge of the Commissioners' Court, and the separate Board of Commissioners be abolished. Thomas Ryan was re-elected County Judge. It is expected that after a few months he will be restored to the position to which he was elected the first time. For over three years past he has simply been probate judge, although drawing the salary provided for County Judge. At the first session of the Legislature, after his election, Senators Brownell and Porter put through a bill creating a separate Board of Commissioners and depriving the County Judge of his powers. This condition has been far from satisfactory to the people and has proven expensive. At the school election held Monday, Charles Albright was re-elected director over R. Koerner by one vote. The other two directors elected were Thomas F. Ryan and George A. Harding. C. O. T. Williams was re-elected clerk. NOTES. Judge T. A. McBride adjourned Circuit Court yesterday afternoon, and left for Astoria to hold a short session. LONDON IS PREPARED FOR THE CORONATION

Week Before the Event, the City Is Gorgeously Decorated.

(Journal Special Service.) LONDON, June 18.—Although it is a week before the coronation, London is already being crowded, and the prices of everything have been advanced. The 7,000,000 people in the metropolis expect to make a great deal of money out of their 1,500,000 guests, and from present prospects they are likely to succeed. The Americans especially are expected to furnish wealth for the Londoners, for while the bulk of the visitors will be from the English provinces, by far the greatest number of foreigners will be from America. Every Atlantic liner that has arrived during the past three or four weeks has brought its full quota of visitors from the United States. At all times Americans are regarded as rich pluckers by the British shopkeepers and hotel-keepers, but this is supposed to be an unusually favorable opportunity for the craft. Interesting accounts are heard at various hotels of the arrangements made for the coronation season. At Claridge's, rooms are sublet by the score and each serving a Yankee visitor have put up \$25,000 for rooms for the coronation procession. SCOPE AND BEAUTY. The decorations of the city have advanced so far as to enable one to form a good idea of the scope and beauty of the general plan. Artists and others capable of judging of such matters unanimously agree that this feature of the celebration will eclipse anything of the kind heretofore seen. A striking feature of the street decorations in Westminster are the triumphal arches at one end of Parliament street. There is a large central arch and two smaller ones in the Gothic style, supported by slender red and white columns, the whole covered with cloth of gold and decorated with the shields and arms of the counties of the United Kingdom and Ireland. On the summit there is an open balustrade of the pinnacles on which St. George, St. Patrick, St. Andrew and St. David are grouped around the lion. The balustrade is decorated with flowers. The arch at Hyde Park corner has two sets of six columns decorated with the royal arms and those of India and the chief colonies. The columns are linked with wreaths of roses surmounted with winged allegorical figures in gold playing musical instruments. A similar arch in Whitehall street is lined with Venetian masks and decorated shields displaying the rose, and has a portcullis of long streamers showing the King's badges and wreaths, roses and the imperial crown with long tassels. Near Abbey Row all the white columns bearing the royal arms and surrounded by the garter rise out of a forest of greenery. The columns are surmounted by winged figures standing on blue spheres linked with festoons of roses and bound with white ribbons.
