THREE BOYS
GO TO PEN

In Judge George's court this afternoon there was quite a volume of business transacted without loss of time. Deputy District Attorney J. Manning had but two informations to file, and in less than 20 minutes' time there were three young men sentenced to 60 days in the penitentiary.

The first information read was one of the State of Oregon vs. F. J. McAllen, aged 22 years, who hails from Chicago, a waiter by occupation, charged with obtaining money under false pretenses. Defendant pleaded guilty, and was sentenced to one year.

Fred Richards and Edward Ross, both of Seattle, aged 17 years each, charged with larceny by bailies of a team, carrying and harness, both pleaded guilty. Ross is an ex-inmate of the Washington Reformatory school, and has otherwise a bad reputation. Richards was given one year and Ross 18 months.

STASHUS IS LUCKY.

Not a true bill was returned against Fritz Stashus, charged with assault with a dangerous weapon on George Buckley. This action was taken in the Circuit Court Wednesday. The case has been expeditiously more or less since the affair took place, on the 15th of last month. George Buckley was a very much more powerful man than Stashus, and it was made clear in the minds of the officials that the fellow was driven to the act only as a last means of defending his life.

FAVORS STOUT.

A report has been current this morning around the Court House that Lansing Stout would be retained as chief deputy clerk in the State Circuit Court department. A petition was gotten up some time ago by a number of the prominent lawyers, urging Mr. Stout's retention. Mr. Stout has been in the office for several years, and is thoroughly conversant and well fitted for the position.

Oil Company to Repair.

A prominent official of the Standard Oil Company said yesterday that the work of rebuilding the company's buildings destroyed by the last fire would be begun as soon as the material for the buildings arrive. It is the intention of the company to spend about \$7,500 on the rebuilding of their works on the same site as it formerly occupied. "There is no truth," said the oil man, "that the company has purchased the property formerly occupied by the East Side Lumber Company. The company already has all the land it needs at present." The Standard Oil Company is willing to do all in its power to make the tanks as safe as it possibly can, and will make any improvement to the grounds that the city council thinks proper, even to building a stone wall around the tanks to their full height.

Longed for Bunchgrass.

E. Skipton, residing near Philomath, has a team of trunk horses. The other day they left his farm, and were finally found at the farm of Tyra Smith, near the Peoria ferry. Every time the ferry steamer touched the Benton County side of the river, the horses tried to get on the boat. The horses were raised in Eastern Oregon, and were evidently anxious to get a mouthful of bunchgrass. Mr. Skipton's brand of oats could never take the place of this succulent herbage.

THEY'RE AFTER
SAM HOWARD

Tonsorial Artist Claims He Has
the Under Hold.

Irrepressible Sam H. Howard, appeared before the executive committee and the Arbitration Board of the Barbers' Union of this city Wednesday night. The tonsorial artist was summoned to show cause why the union shop card issued to him a few days ago, should not be withdrawn. The committee were investigating the charges made by Minor Lewis and Frank T. Rogers, that Howard according to his own affidavit, submitted in the hearing of the injunction case commenced by Minor Lewis in the State Circuit Court, is not an owner. If he is not an owner or proprietor, under the Journeymen's rules, he is a scab, because he is not a member of the union. The Journeymen barbers will not allow a "boss" in the union. They will permit him though, to sign a shop card and employ only union men.

After a prolonged hearing of the facts behind closed doors, the representative barbers decided to await final action pending the investigation of counter charges of a like nature made against Minor Lewis and Frank T. Lewis. Mr. Howard urged the committee to treat all parties fairly, pointing out that those who were trying hardest to injure him, were actually in the same boat with himself.

In an interview today Mr. Howard said:

"They are trying to get me between the Devil and the deep sea. They claim that I am proprietor of a shop in violation of my agreement with Lewis. When I sold but to Lewis I did agree not to go into business again for a period of six months. My affidavit shows that I am not an owner. About two weeks ago I received a shop card from the local union good for a year, now they want to take it from me. They say I am either a proprietor or I procured my card by misrepresentation. Before they get through with me I will show them a trick or two."

"Minor Lewis made affidavit that he was the sole owner of the shop he bought from me. That is false, as in my presence, just after the deal had been closed, he transferred one-half interest in the business to his partner, Frank T. Rogers. That makes Rogers a scab. As such he has no right to work in a union shop. He has withdrawn his name from the union to play the part of a partner in the business. All that I ask is that I be treated fairly. The barbers have promised to look into the facts, and put off further action till the truth has been made known."

"As a matter of fact, I have got Lewis and Rogers going, and if I don't miss my guess, I'll have a padlock put on the front door of their shop by tomorrow. I hold a promissory note signed by Minor Lewis, secured by mortgage. He has defaulted and is liable to the payment of the whole amount at any time. He agreed to pay \$5 a month for a stated period, when the entire balance was to be paid. July 1st a payment was due, and is still owing. Under the terms, I can foreclose at once."

SANCTIONS MURDER

Mrs. Mary Gray Who Shot Her
Husband Is Let Go by
Judge Dunne.

(Journal Special Service.)
CHICAGO, July 3.—Judge Dunne agrees with Judge Tuthill that a woman who is assaulted by her husband should kill him.

The court took the manslaughter case of Mrs. Mary Gray away from the jury and set the woman free.

Mrs. Gray killed her husband March 15 at 5539 Lake avenue. The man was a cook. He did not support her, and they quarreled in their room. He made a vicious attack upon her and she seized his pistol from a table and shot him. Before he died he exonerated his wife.

Mrs. Gray, after the action of Judge Dunne, stood in the middle of the court room and thanked the court and Prosecutor Fiske.

Site Money Raised.

The committee appointed by the East Side Improvement Association for the purpose of raising a fund of \$10,000 for the purchase of a block of ground in Hawthorne Park, East Twelfth street and Hawthorne avenue, providing the fair committee should select the park as a site for the Lewis and Clark Centennial has about completed their duties, the most of the subscriptions received being already collected. It is the purpose of the East Side Improvement Association if the site is selected to erect a permanent building on the block to be used after the fair is over as a city museum. The committee certainly deserve great credit for their efforts to secure the fair for the East Side.

To Fill East Water Street.

A meeting of the property owners along the warehouse district on East Water street between East Morrison street and Hawthorne avenue was held the other day for the purpose of taking action on the proposed plan of filling East Water street with earth. All the property owners assembled agreed to the plan, and the matter will soon be brought before the City Council for action. The Standard Oil Company is the prime mover in the movement, the company's officials saying that as the roadway will have to be entirely rebuilt, it would be better and cheaper in the end to make the improvement a permanent one.

Horse Broke a Leg.

While being driven along East-Belmont street yesterday morning, a horse belonging to a house mover on East Belmont and East Water streets slipped on a loose plank in the roadway, falling into the gutter, breaking a leg. The horse was a very valuable animal, weighing about 1300 pounds, and suffered greatly before Officer Joseph Reining was sent for and put an end to its misery by sending a bullet through its brain.

THE MAYOR'S STAND ON VICE
AND GAMBLING.

A statement of the course to be followed by Mayor Williams for the suppression of vice in the City of Portland has been given to The Journal. He says:

"It is not my intention to attempt to put down all the vice in this city in a day. The closing of all the slot machines in the city which occurred yesterday was but the first stroke of what will be a steady, determined war to make this city a more respectable place in which to live—at least on the surface."

"I have not ordered the immediate closing of all the gambling places in the town for I do not believe such a measure would be effective. What I shall do is to have the persons who operate these hellas heavily fined time and again until I drive them out of business."

"By this I do not mean the imposition of \$5 or \$10 fines. They simply laugh at them. Should the courts uphold me I shall see to it that the fines imposed will be so heavy that the business will become unprofitable and so they will simply quit."

CHIEF GETS HIS ORDERS.

"I have held a long consultation with the Chief of Police and the detectives on this matter and have given them to understand what I expect."

"On one thing I am determined. If I hear of a case in which any officer has accepted money, to connive at any infraction of the law, I will make such a severe example of him that it will not soon be forgotten."

AFTER CRIB-KEEPERS.

The present condition of Fourth street in particular and the North End in general is a disgrace to the city. When a stranger comes to Portland the spectacle of those abandoned women who line Fourth street, and their disgusting solicitations, at once give him a dislike to our city. This shall be stopped.

"I know it is not possible to totally destroy vice in any city, but I am determined that it shall not exist in such a public place and from this time on these people will be so harassed by the officers that they will be compelled to leave."

NEGRO MURDERERS.

"The class of black prostitutes and their paramours, the worst gang of murderers and wretches I have ever known of, must be broken up. I do not wish to cast any reflections on those who have been in control in the past, but I can say that while I am the chief executive of this city I shall leave no stone unturned to clean out every one of these wretches."

HE MEANS BUSINESS.

"Understand me; I have no desire to create any sensation over this matter. My course has been all thought out in advance and while it will take weeks and perhaps months to accomplish my purposes, I shall keep steadily at work until this city is purged of the wretches who now infest it."

"In this fight I expect the aid of every good citizen and as I am sure of the active and willing support of my colleagues in the administration of the city's affairs, I am confident the work will be done in the most thorough way."

WOODWORKERS

Will Go Elsewhere to Secure
Employment.

Many of the Amalgamated Woodworkers are contemplating leaving the city. There are about 40 of them still out of employment, and as there is no likelihood of the mills granting their terms soon they will go elsewhere.

One of the men today said:

"Quite a number of us have been offered positions in the new mill which will start up Monday at Astoria. It will be a strictly union concern and will run on nine hours. Others of us will go to California where we can get employment. By Monday there will not be a baker's half dozen woodworkers left in the city."

In speaking of the men now employed at the mills they say that they are incompetent, and the firms are very much disappointed because their old employees will not give up the fight and return.

DECKHANDS DID NOT STRIKE

The deckhands on the boats have not yet been called out, but many of them are making an enforced layoff on account of the vessels being tied up. It was their intention to go on a strike on July 1, the same date that the engineers chose to quit work. There were some hopes of a settlement, however, and the walkout did not materialize. They receive \$5 per month and found. They want the wages increased to \$40. On some of the lines this amount is paid, and the men are satisfied. The deckhands make the same complaint as the engineers do. "Many of us have families to support," they say, "and since rent and living expenses have increased we need more money. If engineers require \$100 per month in order to live decently, it will be impossible for us to subsist on less than \$40."

LABOR NOTES.

There are no new developments in the ship carpenters' strike. But very few men are out of employment and they are talking of going to other points. One of them left today for Puget Sound, where it is understood that carpenters are in demand at the navy yard near Seattle. If shipbuilders should receive any great amount of work soon the indications are that workmen will be scarce.

The plumbers at Astoria are on a strike, the men demanding \$3.50 for an eight-hour day. Heretofore they have received \$3 and worked 10 hours. They also ask that no one be employed but union men. The Master Plumbers' Association do not object to the wage and hour part of the demand, but they are opposed to employing none but journeyman plumbers. This is the first strike that Astoria has had for years, and it is believed that it will be a very short-lived affair.

The Astoria Central Labor Council held a regular weekly meeting on Monday night at which considerable business was transacted pertaining to unionism. After a number of newly elected delegates had been initiated and taken their seats a communication was read from the Machinists' Union recommending the nomination of labor union candidates of the next municipal and state elections. This recommendation was endorsed and such action will be taken in the future. A communication was received from the
