

ALL EMPLOYED

Bad Weather Paralyzed Outdoor Work for Past Week.

After the inclement weather of the past week or so, during which all industrial operations were practically suspended, general activity is noticeable today all along the labor line.

Carpenters say that by Wednesday, if this weather continues, there will not be over a dozen men of their craft out of employment. With possibly one or two exceptions there is not a job in town designated as unfair, and the sound of the saw and hammer is being heard all over the city.

In speaking of the labor outlook this morning a carpenter remarked as follows: "There is a number of private houses and business blocks going up, and there is great promise of a very busy building period here for the next 12 months. Labor troubles are adjusting themselves and there will not be much further difficulty along this score."

"People are coming in here from the East almost every day, and in order to accommodate them new houses will have to be built. It is almost impossible to rent houses here now, all of them being occupied. The only recourse is to build more houses, and this is being done. A large number of building permits is being issued each week."

"When the erection of new buildings is going on uninterruptedly, it means much to the 12 unions of which the Building Trades is composed. They all come in for a share of the work. I consider the outlook more promising at present than it has been for several months past."

OHIO ODD FELLOWS

DAXTON, O., July 8.—This city is in the hands of the Odd Fellows and their families and friends, who were here from all parts of the state for the annual meeting of the grand encampment and the meetings of auxiliary bodies. Features of entertainment occupy the afternoon and evening, but tomorrow it is expected that the entire day will be given up to the business of the meeting. The city is elaborately decorated with emblems of the order in honor of the visitors.

CANAL SHOULD BE DUG BY 1910

WASHINGTON, July 8.—Work on the Panama Canal will begin about January 1, 1904, and be completed in 1910. Six years of labor and \$180,000,000 cost is the estimate of the Government experts. The order of procedure is: First, to learn whether the French Panama Canal Company can give a clear title; second, to ratify treaty with Colombia transferring concessions and control of route to this country; third, payment of \$40,000,000 to French company; fourth, appointment by the President of a commission of seven to have charge of the work; fifth, award of contract for the construction of the canal.

A commission will probably be sent to Colombia to explain matters. After the treaty has been approved by the South American Republic it will be submitted to the United States Senate. It is expected that the proceedings in Paris can be closed up in a few months and the

BILL POSTERS MEET

MILWAUKEE, Wis., July 8.—The annual convention of the American association of billposters opened here today. There was a large attendance from the principal cities of the United States and Canada. The sessions are to continue several days, during which time a number of questions of importance, affecting theatrical and other people using billboards, are to be considered and acted upon. RAVING MAD

(Journal Special Service.) BURLINGTON, Ia., July 8.—William Trent, a negro doctor, in jail for illegal practicing, flogged John Hendershott, a white prisoner, for playing cards while a minister was reading divine service. Later, while the prisoners were playing cards, Hendershott approached Trent from the rear, pulled his head back, and drew a razor across his throat, killing him instantly. Hendershott soon after went raving mad.

ST. LOUIS, July 8.—The Louisiana Purchase Exposition management has determined to bring if possible the old "Liberty Bell" from Philadelphia to St. Louis for exhibition at the World's Fair in 1904. If the effort is successful it will be the first visit to the territory west of the Mississippi River of this sacred memento of the early days of American independence.

HE SUICIDED FROM SHAME

HARTFORD, CITY, Ind., July 8.—After having roamed the streets as an insane person and doing many things of a disgraceful nature, Joseph Winters, a glass-blower of Anderson, suddenly regained his reason. He was so mortified when told of his actions that he said he would kill himself, and did so by deliberately stepping in front of a Pennsylvania train at Renner, 20 miles from the city. The engineer says that the man was walking beside the track, and when the train neared him he deliberately threw himself in front of the engine.

MISSOURI DEMOCRATS

SPRINGFIELD, Mo., July 8.—The first of the two conventions to be held by Missouri Democrats this year is in session here today with 700 delegates, and twice as many visitors in attendance. The convention will place in nomination three candidates for the supreme bench. It is expected that the Kansas City platform will be reaffirmed, the policy of the National Administration with regard to Cuba and the Philippines condemned, and Governor Dockery's administration and the candidacy of William J. Stone for Senator indorsed.

"MOONBLINKED"

Sailor Lost Sight and Shape of Face in Luna's Beams.

(Journal Special Service.) NEW YORK, July 7.—Thomas Preston, able seaman on the Nova Scotia schooner Sirdar, has been "moonblinked." The Sirdar sailed from Yarmouth December 21, and a few days later sprung a leak. Preston was at the pumps until nearly exhausted and then fell on the deck. It was Christmas morning and a full moon shone on the ship, according to Preston. "When I awakened I discovered that I had been 'moonblinked,'" says the seaman. His face is twisted and one eye is almost blind, due to sleeping under a full moon. Preston's home is in Auburn, N. Y.

FEAST OF SONG

The exposition officials have agreed to have one of the great exhibit places ready for this event. Lighting equipment will be installed and the building will be suitably decorated. A band of 100 pieces will play. The membership of the National Saengerfest extends from the Alleghenies to the Rockies and from the Great Lakes to the Gulf.

FIERCE BATTLE WITH THIEVES

OHIO MAN HUNT WEDDING AMONG THE LENOX MILLIONAIRES

W. H. Vanderbilt's Granddaughter Is Now Mrs. Osgood Field—400 Guests Entertained.

(Journal Special Service.) LENOX, Mass., July 8.—Miss Lila Vanderbilt Sloane was married at noon today to William B. Osgood Field at Trinity Church. The bride is the granddaughter of William H. Vanderbilt and a daughter of Mr. and Mrs. William Douglas Sloane. The bridegroom is a member of the Field family, which has been prominent in the social and business life of New York City for several generations. The doors of the church were thrown open at 11 o'clock. This was an hour before the ceremony, but wedding guests were arriving in such numbers that it was necessary to let them into the church at once to avoid awkward delays. The first four pews on each side were reserved for the families of the bride and bridegroom. Five hundred representatives of the highest society of New York were in attendance. Trinity Church, the scene of many brilliant weddings in the past, was never more beautifully decorated. Vines and flowers covered the columns at each side of the nave and the intervening spaces were spanned with festoons of white and green. At the chancel rail there was a solid bank of azaleas and lilies. The bridal procession passed up the aisle in the usual order: First the ushers, then the bridesmaids, followed by the maid of honor, and then the bride, with her father, William Douglas Sloane. The bride's gown was rich and simple, white satin with a long train. Fine point lace enriched the waist. She carried a bouquet of lilies of the valley and the only ornament worn was a handsome diamond brooch, the gift of the bridegroom. Mr. Field awaited her at the altar with his best man, Mr. Morris Kellogg. The Rev. Harold Arrowsmith, rector of the church, performed the ceremony, assisted by the Rev. Dr. David H. Greer, of St. Bartholomew's Church, New York. When the wedded pair turned to head the procession down the aisle Mrs. Field paused at the first pew and gave her mother, Mrs. William Douglas Sloane, and her sister, Mrs. John Henry Hammond, hearty embraces. The bridesmaids were Miss Florence Tomblow, Miss Frances Crocker, Miss Frederick Webb, Miss Evelyn Sloane, Miss Emily Rogers and Miss Mary Haven. The bridesmaids were gowned in blue and white and instead of the customary bouquets they carried blue and white parasols. The maid of honor was Miss Mary Kernochan. Leaving the church Mr. and Mrs. Field and the guests proceeded to Elm Court, the country home of the bride's parents. Here, in large marquees erected on the spacious lawn, was served a wedding breakfast to 400 guests. Music was furnished by an Hungarian band. The bridal presents were not shown except to the relatives and intimate friends. They included elaborate jeweled ornaments of many descriptions and came from Mr. and Mrs. Frederick W. Vanderbilt, W.
