

THE LABOR MEETING WAS A GRAND SUCCESS

Interesting Speeches by Visiting Officers of the American Federation of Labor.

The labor mass meeting was well attended at Corvair's theater Saturday night, notwithstanding the excessive heat. G. Y. Harry, president of the State Federation of Labor, presided, and called the meeting to order with a few appropriate remarks. The first speaker he introduced was John B. Lennon, secretary of the American Federation of Labor.

Mr. Lennon said that it was a matter of great gratification to him to meet the citizens of Portland. In all the cities he visited, he and those with him had never met with greater hospitality. The following are a few of his sentences:

"During my visit through the Northwest I was impressed," said he, "with the wonderful possibilities which this section of the country presents, and from an industrial standpoint the day is not far distant when it will become one of the greatest inland empires on the face of the globe. The time is coming when the workingmen and women of the Northwest will show to the world what can be attained by force of character and industry."

"Regarding the principles of the Federation of Labor, I wish to state that it is one of the most democratic organizations that ever existed. It is governed exclusively by its members who are scattered throughout every section of the country. Its officers are elected and its policies outlined by an individual expression of the members. I have found by experience that any organization is most effective when all have a voice in formulating it and preserving it. No sectional lines are drawn. We know no North, South, East or West. You are exceptionally favored here. If you could see the conditions existing in some of the larger Eastern cities you would have cause for congratulation. But we must devote our energies to the improvement of those conditions."

"I cannot see why anyone refuses to join labor unions. I will venture the assertion that union people are receiving fully 40 per cent more wages than those who are not organized. The former is also working less hours. It will not be long until every workingman and woman residing in the territory drained by the great Columbia river will be identified with labor unions. It is your duty to further the interests of a movement calculated for the best. But in attaining this end we must keep out of politics. Keep that by itself. There are many wrongs which can be righted in another way. When purchasing goods look for the union label, and buy none unless it bears the union stamp. This is the only method by which the sweat shops can be put out of business. According to population, the people of the West consume twice as much as those of the East. If you refuse to purchase those goods not bearing the union label you will contribute largely in solving the sweat house problem. I ask, in the name of humanity and in the name of children employed in those places, that you no longer patronize them. Be loyal and true trade unionists."

Thomas L. Kidd, president of the Amalgamated Woodworkers and vice-president of the Federation of Labor, was then introduced. He also spoke of the hospital-

SOME RETURN TO WORK.

The planing-mill strike here seems to be about a thing of the past. Thos. J. Kidd, during his visit, conferred with the Amalgamated Woodworkers, but they say no definite plan of action was decided upon as a result. However, some of the best mechanics among the strikers have applied for their old positions, and will go back to work at once. They gave this information themselves, but requested that their names be not mentioned. They have become weary of the prolonged affair, but state that they have not abandoned the hope of the mills some day granting the demand asked by the union. What they have been fighting for was a nine-hour day.

READY FOR THE ASCENT

Busy Scenes Around Mazama Camp at Trout Lake.

TROUT LAKE, Wash., July 19.—"Wah-hoo, wah-hoo, wah-hoo, wah!" "Nanny goat, billy goat—" "Ma-zam-zh."

Amid the buzzes of the Mazamas, as above indicated, the blowing of horns and the good wishes of all the main body of division destined for the summit of Mt. Adams, left Trout Lake this Saturday morning at 5 o'clock.

If enthusiasm counts for anything there can be no doubt about the entire party reaching the highest pinnacle of this grand old mountain.

Of the 73 registered persons composing the Mazama outing, they are for the most part either resting at timber line or well upward and upward toward the summit at this writing, noon Saturday.

The main party which is to make the summit will do so on Sunday and it is not improbable that a short service will be held thereon, the Rev. J. K. Buchanan of Goldendale, officiating.

Since Wednesday the advance party consisting of Prof. Lyman of Walla Walla, Miss Merriam of Brooklyn, N. Y., R. L. Gilson, A. S. Pattullo, Gerald L. Beebe, W. S. Brewster and Ella McBride, of Portland, have been at timber line camp, during which time Kilekita and Mazama glaciers, Buttemont rock and other points of interest have been visited.

Today these, joined by the second party, consisting of Misses Katherine Gile, Kate E. Young, Gertrude Metcalf of Portland, McCarra, A. Curtis of Seattle, Prof. R. B. Lloyd of Vancouver, D. T. Kerr, Chas. H. Brundage, J. H. Closson, M. F. Dillon of Portland, and Geo. Purse of Trout Lake, are making the ascent, the party can be plainly seen, although they are not less than 12 miles from where these lines are written. That they will reach the summit there can be no doubt, they are making good time and as a best indication are keeping close together. MOST UNLUCKY MAN IN ALL THE STATE

Henry Knight, aged 36, is the most unlucky man in Oregon. When he leaves the Good Samaritan hospital in a few days he will have recovered from the latest of a series of accidents that have placed him on the verge of the great beyond and allowed his escape as if by a miracle.

His latest accident was the explosion of phosphorus at the St. Johns match factory. He poured water on the molten mass and was blown 10 feet into the air. The liquid took his hair off, scalded his hands and face and nearly destroyed the sight of an eye.

His pain was agonizing, but Knight had become so accustomed to bodily injuries that he remarked, after being rescued from the mass of scalding debris, that, as he didn't feel very good, he guessed he would have to go to the hospital once more. This accident, while serious, is not to be compared with the one in which he was shot through the body a few years ago. The bullet went clear through him, but Knight didn't mind a little thing like that, so he went on his way rejoicing until he mistook his foot for a log and cut it half off. Dr. Thornton was called, and he was preparing to administer an anesthetic when Knight protested and said, "Sew it, doctor, while I see how you do it." He even suggested that the surgeon take smaller stitches, as he said they healed quicker.

Knight recounts several other minor accidents, but he always escaped alive, and seems cheerful over the outlook that no matter what happens to lay him up he will escape death in his usual miraculous manner.
