

THE ODDS ARE ALL AGAINST LANKY BOB Gossip of the Condition of the Big Pugilists—Training Stopped.

SAN FRANCISCO, July 22.—As the day for the big fight between Jeffries and Fitzsimmons approaches, the interest naturally grows keener and the betting heavier. Heretofore the prevailing odds have been 10 to 4 but a steady inflow of Fitzsimmons money yesterday afternoon and last night cut the odds down to 10 to 4.

Neither fighter will do any more hard work, taking only light exercise enough to keep limbered up. Both men will omit their usual boxing. Each will do a little shadow sparring and swimming, which, coupled with a couple of rub-downs a day, will constitute their exercise.

GLUTTON FOR WORK. "I have known a good many fighters in my time," said Delaney this morning, "but never was there one like Jeff for hard work except Corbett. When I had 'Gentleman Jim' he was just the same as Jeff—work, work, work, and no end of it."

DOWN TO WEIGHT. Jeff is now down to the weight, 210 pounds, that he wants to go into the ring with. If the fight were to come off to-night he would be ready and fit. There is nothing more that he can do to improve his condition. When he got up yesterday he said: "If I only feel like this on the night of the fight I'll be pleased, and so will all my friends later."

WITH FITZSIMMONS. Since Fitzsimmons has arrived here and established himself in the California hotel and his training quarters at the Olympic Club, he has attracted a great deal of attention. The club gymnasium is packed daily but Fitz is virtually through with his work of preparation and simply awaits the tap of the long to mix it with the "big fellow." Fitz's last day at Skaggs Springs is described by one who was present as follows:

"This morning Bob arose at 7 o'clock and took a walk around the grounds until 8. Promptly at that hour a party of ladies and gentlemen assembled by invitation of Fitzsimmons and proceeded by stage and horseback to a rustic hostelry in the mountains, where a luncheon was awaiting them. Fitz and his sparring partners went on foot, while I followed them on horseback, making the pace. The road was a rough one and through the mountains, but it seemed to make no difference to Bob, who arrived there as fresh as if the jaunt was only a mile instead of a 55-minute run. When we arrived the busy blacksmith lay down in a hammock and slept until he was called for luncheon. He did not look as if he were worrying about the fight very much. At the luncheon table Fitz ate everything in sight with a relish, and then went back to his corner in the hammock and finished his snooze."

"One thing I forgot to mention. Fitz drank a bottle of beer, and in that respect he is different from Jeffries, who only rinses his mouth out with it. Bob thinks a bottle of beer will not hurt him when he feels like drinking it."

A TERRIBLE HANDICAP. Grane, like others who have seen Fitz at work here, is impressed with the healthy, ruddy appearance of the Cornishman, but is deterred from making enthusiastic remarks concerning Fitzsimmons' chances by the reflection that Bob is to tackle a man nearly 15 years younger and possibly 60 pounds heavier than himself. There is no denying that the handicap is a terrible one, but those who are close to Fitzsimmons cheer themselves with the argument that Fitz has been heavily handicapped and has battled against odds in nearly every fight he has engaged in.

Now his knuckles, while they bear signs of hard contests, are free from bruises and inflammation, and his elbow does not trouble him at all. He is in as good condition as it is possible for him to be, and the thought makes his trainers happy.

FITZ ON THE RULES. Fitzsimmons in speaking about the conference with Grane said: "Never before have I had anything to do with the referee before the fight. Grane has been at the Jeffries fight and he had come up here to see me and I wanted to impress certain parts of the rules in his mind, which I think he will always have to keep before him. When clinches take place I want a breakaway at the word from the referee. I don't want to lug around Jeffries' superior weight. Another thing that we considered was the jabbing with the shoulder. Jeffries could miss with his left and play with his right and his weight would have telling effect."

"Another thing we considered was the bandages. By the articles of agreement as signed by Jeffries and myself it was agreed that they should be soft bandages, but I wanted it understood that they were to be soft surgical bandages. The bandages will not be put on until after we have entered the ring." Eddie Grane in discussing the coming fight said: "No one can break away such as Jeffries and Fitzsimmons if they want to hang on, and I am not going to try, but the men will break when I tell them to, for the rules are going to be obeyed."

There does not seem to be any doubt but that the Portland and Butte teams will have a full week of good ball-playing weather. Both teams arrived in town yesterday. LATEST EDITION SAD STATE OF AFFAIRS

County Sends Patient to Local Hospital for Treatment.

The County Judge and Board of Commissioners were brought face to face today with the need of a hospital in the city limits, equipped to handle all classes of patients.

On the recommendation of County Physician Geary, an order was made transferring Irving L. Vincent to the St. Vincent hospital. The patient is without means and is suffering with an affliction of the eye. A private physician has had charge of the case and has been visiting Vincent in a private residence. The man's funds are exhausted and it was necessary to apply to the county for aid.

The county hospital is so far out of town, three miles from the city limits, that it is impossible to give the case the proper treatment. Dr. Geary, temporary county physician, said the patient should be visited several times a day. The distance out to the poor farm is too great to make these trips. The only thing to do was to send the patient to a local hospital at the expense of the taxpayers.

The accommodations of the county hospital as well as the poor farm, which are in the same tract, are insufficient. The buildings are all of wood, the rooms are small, and the quarters are overcrowded. The water is poor. Commissioner Showers said today that the county should have better buildings and that a local hospital was one of the chief necessities of the hour.

Up to the time of Dr. Harry McKay's term of office, just completed, Multnomah County paid out on an average of over \$100 a month to local hospitals and doctors. Dr. McKay, according to one of the Commissioners, saved a great part of this drain by sending more of the patients to the county hospital.

His efforts have borne fruit in the greatly reduced expense to the county, but the saving of dollars and cents was effected at much inconvenience to attendants and patients.

IN A SHORT TIME the shipload of rails ordered from Europe by the City & Suburban Railway Company will arrive. Preliminary arrangements are now under way to lay these rails along Third and Morrison streets. At Third and Flanders streets a curved cross-over is now going in to connect the Third and Second street lines.

In a day or two it is the purpose of the Portland Railway Company to put crews of men to work to remove the old tracks on Washington street and to lay new rails along the route. As soon as the switches arrive to be used to throw cars over upon the undisturbed part of the line, the work will be pushed with all possible speed that the public may not be hampered any more than is avoidable. A night crew will be put on in addition to the day crew.

Company, respectively, besides Mr. McKinney's assistants, Messrs. McKensie, Krouse, Townsend and others, left for the East today. On the way they will visit Hood River, The Dalles, Grants, Arlington and other points. They will go over the Columbia Southern and they will visit La Grande and take in the Grand Ronde Valley.

HINTS TO WOMEN

PRETTY SUMMER COATS. Very novel are the jackets of colored pique, for wearing with mousseline or lace inserted linen skirts. In front they are enriched with lace, which is carried like a draped belt to the back of the waist, and finished off with large buttons, a narrow pleated habit basque depending from the waist behind.

THE VALUE OF SUNSHINE. One of the simplest, cheapest and best sterilizers is sunshine, and it is important to allow as much sun in a sick room as possible. The same rule is applicable to the rooms of healthy people. The good effects of "sun bathing" in the treatment of convalescence is ample proof of the utility of the rays of the sun for therapeutic purposes.

CREAM CHEESE SANDWICHES. Make some round biscuits with these paste (such as would be used for cheese straws), and when they are cold spread them rather thickly with Neufchatel cream cheese; place two of the biscuits together to form sandwiches, put a little piece of watercress on the top of each and garnish the dish on which they are served with small ferns.

FOLDING A MAN'S COAT. The proper way to fold a man's coat is to lay it out perfectly flat, with the wrong side down. The sleeve should be spread out smoothly and then folded back to the elbow until each end of the sleeve is even with the collar. Fold the revers back and then double the coat over, folding it directly in the center seam, and then smoothing it out carefully.

THE HANDY WRIST BAG. Into greater and greater favor grow the modish and convenient little wrist bags into which one thrusts any number of small articles, including one's (once so-called) pocket handkerchief. Why the pocket should continue to figure when we are pocketless is a conundrum. Samples, pencils and card-case also find lodging therein. Some of these have a pocket on the outside, and many have the purse built inside.

A DAINY LUNCHEON. A luncheon served to the members of a whist party, all women, consisted of cold pressed chicken, served with rolled bread; a salad of ripe, firm tomatoes, stuffed with chopped cucumber seasoned with salt, pepper and onion juice and topped with a dessertspoonful of mayonnaise dressing; sherbet with little cakes, and a fruit punch containing tea. The inside of the tomatoes had been removed and the cavities treated with French dressing before the cucumber stuffing was put in and the flavor was delicious.

SEEN IN THE SHOPS. Ponjee dresses in all degrees of fetchingness. So many ostrich feather boas. Stockings boasting both lace and stripes. Charming hats in horse-hair braids. Smart showings of linen frocks.

ABOUT THE SHOES. Never wear a shoe that will allow the great toe to lie in a straight line. Never wear leather sole linings to stand upon; white cotton drilling or linen is healthier. Never wear a shoe with a sole narrower than the outline of the foot traced with a pencil under the rounding edge.

A SUMMER DELICACY. Fried peppers are not any too well known. The peppers should be sliced crosswise, freed from the seeds and left in cold water for a quarter of an hour or more. Drain and dry these slices, sprinkle over them a little salt and dip them into flour. Have ready a little olive oil in which to fry the peppers. Do not let them brown too deeply, and serve with steak.

FOR THE BABY. Everything for the smart baby, from shoes to pillow-slips, are hand-made, and everything is of featherweight. Tucks and frills are not smiled upon by the mother of the smart baby of today. Ruffles, pinked edges and embroidery have taken the place of clumsy hems, lace and ruffles. A flannel slip, low-necked and sleeveless, takes the place of the heavy flannel petticoat, which made the old-time baby hot and unhappy. Socks and undershirts of fine-spun silk keep the new baby warm without encumbering him with useless and clumsy garments.

FOR THE DAINY WOMAN. The woman who has never tried a spraying of some delicate toilet water after an exhausting day of business, shopping, calling, study, or brain work, or the multiplicity of domestic duties has not learned its value in toning up the nerves. There are actual medicinal properties in a well prepared toilet-essence of violet, orange flowers, orchid, vervain, or sweet lavender—whether applied to the body or diffused by an atomizer through the room.
