SOFTBALL LOOP PLAY BRIEFED FOR TOURNEY

ASHLAND'S softball league's second-half schedule was shortened by officials and managers Tuesday night when they met to consider means of determining this city's representative at the district tournament playoffs in Grants Pass Aug. 14 and 15. Ashland's team will play the Grants Pass champions in the first game of the semi-finals Monday, Aug. 14, and the winner of that contest will meet the victor of the Medford-Klamath Falls battle the following evening for the district championship and right to enter the state tournament.

President Howard Wiley and team pilots voted to conclude regular league schedule with tonight's games, top four teams at that time to enter a playoff series Monday night, winners to meet for the second half title Wednesday evening after the two cellar outfits battle to climb out of disgrace. Should the second-half victor be other than the first-half champion Dodgers, a Friday night playoff would be held. Following the two nights of play in Grants Pass, the Miner Press will meet the traveling Negro Ghosts from Sioux City, Ia., colored clowns, in an exhibition game on the Ashland high school field Wednesday, Aug. 16. The Miner outfit will be strengthened for the laugh-fest with players from other league teams.

Tonight, final evening of the local schedule, the ever-threatening Elks nine will meet the league-leading Dodgers in the 8 o'clock encounter while in the second game the Miner Press will fight for a chance to enter the finals with the Rogues. A loss for the Printers would send them to the cellar with Talent, while a win would place the league in a four-way tie for second place, necessitating an elimination round to determine four playoff qualifiers.

Barksdale Pitches Rogues to Best Elks

The six-hit pitching of Arch Barksdale gave the Rogues an 8 to 4 win over the Elks at the high school field Friday night. The Elks started the scoring in their half of the second on two walks and a double and it was not until the fourth that the Rogues were able to catch up.

Rogues, Elks Top Pine Box, Talent

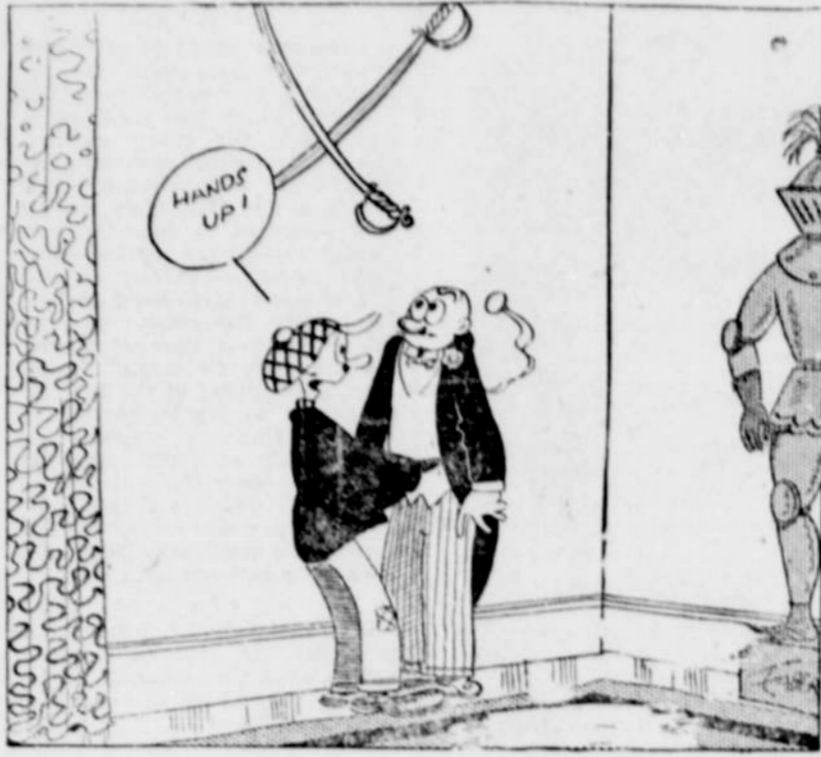

A-T'S WILL SEEK DORRIS REVENGE ON LOCAL FIELD

ASHLAND-TALENT'S steadily climbing baseball team will meet Dorris, Calif., on the local high school field at 2:30 p. m. Sunday, Aug. 6, with a two-fold purpose. Vengeance for a blind-Tom steal of an earlier game at Dorris will be the immediate reason, while a whack at the league playoffs and the resultant chance to meet Medford again will be the other. To qualify for the Shaughnessy playoff, the A-T's must win Sunday's game here and down at Grants Pass in the Climate city the following week-end.

The Dorris Lumberjacks of Red Toibert last week-end smothered Medford's Craters and themselves are fighting for a place in the playoffs. Against the invaders Manager Charlie Skeeters—who had to be persuaded to play Dorris again at all after the alleged "steal" in the California town—will start his game-winning favorite, Frank DiSordi on the mound, with Rich Skeeters catching. Added to the A-T lineup will be Dick Porterfield, who last year was a regular here and recently was traded from Medford in exchange for an idle A-T hurler.
