Poor Headlights Are Cause of Accidents

Headlights out of order or in poor adjustment constitute a serous accident hazard as winter brings on longer hours of darkness, Secretary of State, Bob Farrell said today.

He said accident reports indicate many cars are operating with headlights either in such poor adjustment or not functioning at all. This is due chiefly to the fact there are many older cars on the streets and highways today and to the fact that drivers neglect having their lights check ed periodically ,he said.

It is important, from the standthat headlights function properly. In some cases the upper beam may be correct, while the bulb for one or both of the lower beams may be burned out. Some cases have been reported in which lights, damaged by minor accidents, have not been repaired promptly.

Farrell suggested drivers have their lights cheked to be ready for the fall and winter months. He said tthey should be checked to make sure all bulbs are burning, that reflectors are clean and that the entire light is in proper adjustment.

"Then, when meeting cars at night, always remember to use the lower beam, to avoid blinding the approaching driver," he said. "Drivers blinded by glaring headlights often are involved in accidents due to their inability to


Near School Houses Calling attention to an upward trend in traffic accidents involving children under 14 years of age, age, Secretary of State, Bob Farrell today urged drivers to in-crease their caution when driv-

ing in the vicinity of schools as the fall term opens this month. So far this year, fatalities among children under 14 years of age are 26 per cent greater than for the same period last year, Farrell said. Child injuries have increased 52 per cent.

A great proportion of the accidents in which children are kill ed or injured occur when the point of safe operation at night, | child dashes out into the path of an approaching car, the secretary of state said. For that reason, he urged drivers to anticipate this possibility when driving past areas where children are observed.

"As school opens, the school safety patrols will be in action again," he said. "Drivers must cooperate with these patrols in the interests of protecting younger children as they cross the streets. When the patrol mem-bers signal that the intersection is occupied, slow down and stop if necessary to yield the right of way.'


