# Political Pot Begins Bubbling and Boiling in Jackson County This Week

Secretary of State Earl Newbry, Ashland, has filed for the Republican nomination as secretary of state. This leaves a clear field for several potential state senators in Jackson county.

If nominated and elected, Newbry pledges to "conduct the public business as I have my own. My door will always be open to any individual or group seeking service of my office. My position, or answer, on any question will not need interpreting. It will be frank and forthright."

As a slogan on the official ballot, Newbry asks that the following be placed after his name: "Assure yourself of a friend in public office. Frankness with courtesy."

Newbry, who had served two terms in the house, was serving his second term as a member of the senate when appointed secretary of state by Governor John H. Hall.

The Republican Central Committee, left with a senate vacancy on its hands, will give its blessing to either William McAllister or Hilding Bengston. Neither has made any commitment to date as to his decision concerning the matter. Bengston is presently a state representative.

McAllister, Medford attorney, was a member of the house prior to the war, and served as speaker of that body during his last session.

Ben Day, Sam's Valley rancher, who has been off and on the fence has not stated definitely whether he will seek the post or not. Everett Faber, Central Point, has announced his candidacy for the senate.

Frank Van Dyke, currently a member of the house of representatives, has announced that he will enter the lists hoping for re-election. Van Dyke has his sights set on the speaker's seat.

E. H. Mann, Medford manufacturer, has been urged to seek the Republican nomination for representative, but has not definitely committed himself.

To date the Democratic party has made no announcement as to candidates seeking state seats.

Charles Hockersmith, Phoenix, is the only Democrat who has thrown his hat into the ring in the county so far. Hockersmith is planning to run for county commissioner.

Robert Lytle, Valleyview, who is presently a county commissioner, has made no commitment concerning his plans. Arthur Powell, Central Point, announced his

candidacy the first of this week. Mayor C. A. Meeker, Medford, has been requested by friends to run for commissioner but has given the matter no consideration as yet. Chester Wendt, Jacksonville, has also been mentioned among possible candidates for one of the commissioner's posts.

In the city of Ashland it is as yet a bit early to determine what particular people will make a bid for the city council and the Mayor's post.

Mayor Thornton Wiley, who has held the post since 1932 stated that it was a bit early to decide whether or not he would run again this year, and that as the situation developed he would make up his mind.

Thus no mayoralty candidates nor candidates for the city council seats have appeared. Three vacancies will show up on the council: Jake Weitzel, Walter Redford and Harold Merrill will have served their terms. None of the three have stated at this time whether they will run for re-election or not. Seemingly the situation at the close of the year will determine their stands.

The next few weeks will bring out a rash of candidates for county and state offices, the majority of whom will be seeking Republican favor in the primaries, which in this region, is practically tantamount to election.

## President's Ball To Climax Polio Foundation Drive

Saturday night, January 31, the 1948 March of Dimes campaign will come to a close with the annual President's Ball which will be held this year in the Elk's Temple. Admission will be \$1.50 per couple according to Don MacWhirter and Dyer Huston, co-chairmen of this year's March of Dimes campaign.

The dance will be informal and is open to the public. Tickets are presently on sale or can be purchased at the door. Special concessions will be available at the hall, and the Elk's dance band will furnish the music.

Returns from the drive are incomplete as yet but MacWhirter stated today that the present results indicated a possibility that this year's drive would exceed in amount collected in the 1947 drive.

The March of Dimes show was presented at the junior high school auditorium Wednesday night, played to a slim audience. Comments on the show indicated that it was a fine variety revue. Robert Reinhold acted as Master of Ceremonies and Dr. Elmo Stevenson spoke briefly. The Ashland high school quartet and the high school band were the two local groups which appeared. The remaining 16 acts were selected from the best amateur talent in Jackson county.

Chico State's Wildcats will invade Memorial gymnasium on the campus at Southern Oregon College this Friday and Saturday to attempt to topple the Red Raiders of Southern Oregon College who lead the Far Western conference basketball race with seven wins and one loss.

The Chico State club is only one game behind the Raiders in conference standing having dropped

only two games, one to SOC and the other to Humboldt.

If Ted Schopf's club wins both Chico games the Far Western title is practically assured the Ashland club, however, dropping either of the games can make it a wide open race for the conference title.

The Raiders will begin February with two more games on the

home court. The Gators from San Francisco state will play here Monday and Tuesday, February 2 and 3.

Last week the Raiders, sparked by Bobby Hoefs, took two games from Humboldt in a series played in Ashland. The first game ended 59 to 51, and the second closed with the score 51-36. Winning those two games gave the Raiders a record of six consecutive wins.

## Spanish Swindle Swindlers Offer Money And A Trip With Pretty Daughter For Release

Dr. Bracker Aids  
In Exposing The  
Spanish Swindle

"The first thing I did was notify the FBI," said Dr. W. E. Bracker Ashland dentist who received a Spanish Swindle series of letters from Joseph Martin, reputedly a Venezuelan financier of French origin, who claimed he was languishing in jail in Mexico city. "The FBI in turn referred me to the Postal inspectors who have been handling the case."

Bracker received the first letter from a Mr. M., November 27. It was in the form of a come-on and no money was requested. The second letter, which arrived in Ashland, December 18, stated that Mr. M. was in reality Joseph Martin, and that if Dr. Bracker would proceed with \$8,750.00 to Mexico City certain suitcases containing custom claim checks could be released, the claim checks thus obtained could be used to reclaim certain trunks which were being held in a custom's warehouse in the United States. In these trunks in the United States, Mr. Martin stated, was \$375,000. Half of this would be given to the Doctor if he came through with the \$8750.00.

Mr. Martin's second letter contained explicit instructions as to the time Dr. Bracker should arrive in Mexico City, told him at what hotel he should register, and how he should get in touch with an intermediary. Martin also stated that his beautiful 18-year old daughter would accompany Dr. Bracker to Texas where she would get one-half of the \$375,000.

Postal Inspector  
Warns Southern  
Oregon Residents

"Would you like to get in on a deal to get one-third of \$375,000? Everyone would like to have the money, so the main question is would you fall for the 'Old Spanish Swindle'?"

Post Office Inspector J. A. Eldswick reported that recently several letters from Mexican swindlers have been received by business and professional men in Southern Oregon.

The letters, mailed in Mexico, begin by asking the addressee if he would be interested in doing a big favor and helping out the man's daughter. Next, the letter writer cites a hard luck story of being in debtors prison.

"I have \$375,000 in American currency locked up in a trunk which is in a customhouse in the United States," the swindler writes. That is where the person who gets the letter comes in.

Authorities point out that Americans who have gone to Mexico City with the \$8750.00 to rescue the financier and save the beautiful maiden, have in the past, returned with a lump on the noggin and a bad taste in their mouth.
